



SPECIAL 2011 ANTLERLESS DEER HUNT

GREEN VALLEY STATE PARK

PERMITTED WEAPON IS MUZZLELOADER ONLY

HUNTING DATES: NOVEMBER 19 AND 20, 2011

Information (Please read before completing application):

1. License applications will be accepted from **September 1 – October 12, 2010**. Do not mail the application prior to Sept. 1st. Those received after Oct 12th will be rejected.
2. 30 applications will be drawn and licenses issued to *Iowa residents* for the hunting season and dates indicated above. **Each license issued from the drawing will be for two (2) antlerless tags. If you are a successful applicant, you will be required to purchase two (2) tags.**
3. Only one application per individual per envelope will be accepted (Exception: 1 adult + 1 minor child 12 years or older. A child must have completed a Hunter Education Course to participate in this special hunt.)
4. The license fee of **\$41.50** (check payable to **Union County Recorder**) must be paid at time of this application. **If you have already purchased an antlerless tag for \$28.50 for other deer hunting, only enclose \$26.00 for the Green Valley Hunt.** The fee of successful applicants is non-refundable. *Fee of unsuccessful applicants will be returned.*
5. The harvest is restricted to antlerless-only deer.
6. Only persons with a special Green Valley gun deer license will be permitted in the State Park during the above dates. A youth hunter age 15 and under may have an adult mentor with them if the mentor has a valid hunting license and has paid the habitat fee, if the adult is normally required to have them to hunt. Only one youth hunter may accompany each adult mentor. The mentor is not required to purchase deer tags, thus, the mentor may not harvest a deer.
7. **Successful applicants will be notified by telephone or e-mail;** and are **required** to attend a one-hour safety and orientation meeting at the *Park Office* prior to being issued a special Green Valley Muzzleloader-Only deer license. The orientation meeting will be **Tuesday, Oct. 25th at 7:00 p.m.** Proper identification will be required for admittance to the meeting. We will ask to see a valid Iowa Hunting license.
