



# SPECIAL 2011 ANTLERLESS DEER HUNT

## Stone State Park

**PERMITTED WEAPON IS: ARCHERY ONLY**

**HUNTING DATES: October 1, 2011 to December 2, 2011**

**Information (Please read before completing application):**

1. License applications will be accepted from Iowa residents August 1-31, 2011.
2. A quota of 50 antlerless deer licenses will be issued to no more than 25 hunters. If more than 25 applications are received, a drawing will occur and the first 25 names drawn will have an opportunity to buy 1 or more licenses. If less than 25 applications are received, each qualified hunter will have the opportunity to purchase 1 or more tags. Only one application per individual per envelope will be accepted (Exception: 1 adult + 1 minor child 12 years or older. A child must have completed a Hunter Education Course to participate in this special hunt.)
3. Successful applicants must attend one of two safety/orientation meetings. Once the hunter has attended the required safety meeting, they will be allowed to purchase the antlerless tag at Scheels in Sioux City. The hunter will not be able to purchase the tag before attending one of the safety meetings. License fee is \$28.50 (first license) or \$13.00 (if second antlerless tag).
4. **Successful applicants will be notified by telephone or e-mail;** and are **required** to attend a one-hour safety and orientation meeting. Applicants will be notified of the meeting dates when drawn. A photo identification (and hunter education certificate, if required) will be required for admittance to the orientation meeting.
