2011 LAND AND WATER CONSERVATION FUND

Congress approved an apportionment of \$490,133.00 plus \$80,408.90 available from reapportionment funds making the 2011 allotment \$670,541.90 for the State of Iowa. One half of Iowa's apportionment, \$335,270.95 is available to cities and counties for outdoor recreation acquisition and development projects.

A total of 15 applications were received by the March 15, 2010 deadline. Grant requests for the 15 applications totaled 1,045,754.50 for a variety of activities including general park improvements, campground developments, playgrounds and land acquisitions. (Some applications included aspects that fit into more than one of the previous listed areas.)

A five member committee reviewed the 15 applications and scored/ranked them based on the following criteria:

Relationship to SCORP Priorities (Statewide Comprehensive Outdoor Recreation Plan)

Direct Recreation Benefits Provided

Local Need

Quality of the Site

Additional bonus points and penalty points are also included in the scoring system. They are based on such things as level of prior assistance from the LWCF; special features for the elderly and handicapped; minority populations served; degree of public participation and support; recycled content material use; and level of planning that has preceded the application for a LWCF grant.

The top five projects on the list were approved for full funding by the Natural Resource Commission on May 13, 2010. The sixth project listed will receive partial funding.
