BRIEF DESCRIPTION OF FACILITY

The Iowa Department of Natural Resources (Department) has received a variance request from the Delaware County Solid Waste Commission (Permittee) for the Delaware County Sanitary Landfill (Facility), a municipal solid waste sanitary landfill originally permitted by the Department in 1974. The Facility is classified as a municipal solid waste sanitary landfill which received a closure permit from the Department on June 30, 2000.

NOTICE

The Department has received a variance request from the Permittee to authorize groundwater detection monitoring in accordance with subrule 567 IAC 113.10(5) and statistical analysis in accordance with rule 567 IAC 113.10(4) instead of subrules 113.2(5)"d" and 113.2(5)"e" for the wells. Additionally, the permit holder is requesting a variance to allow monitoring well maintenance performance and reevaluations to be conducted in accordance with 567 IAC 113.10(2)"f" instead of 567 IAC 113.2(5), which by reference requires following the provisions of 567 IAC 113.21 (effective 01/15/03) that include in situ permeability testing every five years.

After review of the application materials, the Department has made a preliminary determination to approve the application for permit renewal. Once processed, copies of the Department's final determination may be reviewed at the Department's Regional Field Office located at 909 W Main, Suite "D", Manchester, IA 52057 and 563/927-2640. The file with regard to the Facility is available for inspection between the hours of 8:00 a.m. and 4:30 p.m. at the Department's Records Center at 502 E. 9th Street, Des Moines, Iowa 50319-0034. The Department Records Center will make copies from the file upon request. There is a charge for copy orders. The procedures that the Department will follow with regard to this permit application or postpermit modification request are set forth in Iowa Administrative Code 567 Chapter 113. The Department strongly recommends that interested persons review the chapter.

COMMENTS SOLICITED

By this Notice, interested persons are invited to submit written and signed comments to the Department regarding this notice. To ensure consideration, comments must be received by the last day to submit comments identified above, and should include the following:

- A. A statement of the person's interest in the Department's determination;
- B. A statement of the action the person wishes the Department to take, including specific references to sections of the request that the person believes should be changed; and
- C. The reasons supporting the person's position, stated with sufficient specificity as to allow the Department to investigate the merits of the person's positions.

Any submissions should display the public notice number next to the address on the envelope and on each page of any submitted comments, and include a return mailing address and telephone number. The Department will consider all comments received during the comment period and may modify the determination based on those comments. Comments received by the Department in response to this notice will be made part of the public record with regard to this permit.

The responsiveness summary to public comments received will be mailed to each commenter at the address on their comment submittal, and may also be viewed at the Department's Records Center at 502 E. 9th Street, Des Moines, Iowa 50319-0034. The public record files for facilities will be available for inspection at the Records Center between the hours of 8:00 a.m. and 4:30 p.m. The Department Records Center will make copies from the file upon request. There is a charge for copy orders. REQUESTS FOR PUBLIC HEARING

The applicant, any interested agency, person or group of persons may request or petition for a public hearing with respect to the Department's determination to approve or deny an application or postpermit modification request. Any such request shall clearly state issues and topics to be addressed at the hearing. Any such request or petition for public hearing must be filed with the department within 30 days following the date of the public notice and shall indicate the interest of the party filing such request and the reasons why a hearing is warranted. The department shall hold an informal and noncontested case hearing if there is a significant public interest (including the filing of requests or petitions for such hearing) in holding such a hearing. Frivolous or insubstantial requests for hearing may be denied by the department.
