Commission approval is requested for a contract with JEO Consulting Group of Ankeny, IA.

Contract Terms

Amount: Not to exceed \$59,490.00 Dates: May 10, 2024 to May 31, 2025

Funding Source(s): Woodland Health Initiative and Federal Bipartisan Infrastructure Law

Contract Purpose: To assist 15 lowa communities with planning and managing their urban tree resources, development of response to the presence of Emerald Ash Borer and other tree pests and problems. As a part of the project each lowa community included in the contract will receive an inventory of street and park trees, a visual survey of forest health symptoms, a summary of benefits those trees, and an urban forest management plan. Tasks include:

- Inventory street and park trees in identified communities. Collect data for each tree that includes all require categories for data collection, i.e., GPS derived locations for each tree and data elements for each tree.
- Visually survey all trees for signs and symptoms of invasive pest and disease in the identified communities, return data to DNR in shapefile format via e-mail.
- Calculate the benefit of the street and park trees using the most current version of i-Tree and create maps of the trees for each urban forest management plan.
- Finalize urban forest management plans for the identified communities and submit plans to DNR for approval.
- Presentation of the urban forest management plans to each community.

Communities include: Alton, Clarksville, Gilbert, Gilmore City, Glidden, Greenfield, Hawarden, La Porte City, Murray New Albin, New Sharon, Remsen, Schaller, Wheatland and Winthrop.

This process has been done annually since 2012 for 207 other communities in total. These inventories and plans have aided communities with current information to make tree care and budget decisions. The data collected in these assessments have helped prioritize removal and treatment of ash trees as well as monitor for pests like walnut twig beetle which is necessary for lowa to continue the international sale of wood products.

Selection Process Summary: The Department solicited proposals from 194 in-state arborists and national tree inventory companies. Proposals were scored based on the criteria as described in the RFP which included cost of service and experience conducting street tree inventories and writing urban forestry management plans which includes work plan, past work projects, capacity of respondent and mechanism for GIS collection.

Criteria Reviewed: Cost, brief company overview including capacity to complete the Statement of Work Work Plan including time frame, experience conducting street inventories and writing urban forestry management plans, experience and references that demonstrate the expertise and ability of the respondent to provide the Statement of Work described in the Informal RFP, the capacity of the respondent to complete responsibilities described in the Statement of Work, and the mechanism for creation and delivery of GIS file geodatabase.

8. Contract Amendment with Trees Forever, Inc.

Commission approval is requested for a contract amendment with Trees Forever, Inc., of Marion, Iowa.

Contract Terms

Amount: Not to exceed \$ 350,000.00

Dates: May 10, 2024 through October 14, 2026

Funding Source(s): General Fund (Woodland Health), US Forest Service Federal Funds

Contract Purpose: The DNR Forestry Section maintains Forest Health and Urban Forestry programs to assist communities with analysis, planning, and management of their tree resources. Trees Forever, Inc., is a conservation organization that works to improve the environment of Iowa and Illinois by promoting stewardship. The DNR and Trees Forever, Inc., have a history of working together to advance shared priorities.

The DNR's purpose in entering into this cooperative agreement is for the DNR to provide funding for Trees Forever to hire and employ up to four Community Forest Health Technicians. The DNR will provide the structure of a Forestry Program within which the Technicians will work, monitor the day-to-day work of the Technicians, and provide training, vehicles, computers, communications, and GIS support. The DNR and Trees Forever will coordinate efforts and determine work and location priorities for the Technicians. These priorities will be consistent with the goals and objectives in the State Forest Action Plan. This partnership will help achieve joint goals and objectives with DNR to grow healthy community forests in the state. Tasks for the Community Forest Health Technicians include:

- Assist communities by conducting tree inventories, canopy cover assessments, and preparing management plans
- Perform risk tree assessments to help communities and public areas maximize safety
- Coordinate volunteer efforts and help implement replanting programs for communities

This amendment adds additional money and time to the cooperative agreement.

10. Contract with Pheasants Forever, Inc.

Commission approval is requested for a contract with Pheasants Forever, Inc., of Saint Paul, Minnesota.

Contract Terms:

Amount: Not to exceed \$7,440,709.00 **Dates:** July 1, 2024 to June 30, 2030

Funding Source(s): Fish and Wildlife Trust Fund

Contract Purpose: The DNR is partnering with Pheasants Forever, Inc. (PF) to provide up to twenty Wildlife Management Specialists to carry out habitat improvement and wildlife management activities on public and private lands.

The DNR Wildlife Bureau actively manages public land and wildlife populations statewide to maintain biological balance and for the benefit of the public. This cooperative agreement will allow the Department to work with PF to fill critical needs in a fiscally responsible manner that can be adjusted depending upon the availability of funding as well as the land and wildlife management needs on the ground. Similar contracts between the Department and PF have been implemented.

Under this contract, PF will hire and employ up to 20 Wildlife Management Specialists for a period of up to six years. The Wildlife Management Specialists will work closely with DNR Wildlife staff to conserve and enhance wildlife habitat on DNR-managed lands. They will perform a variety of activities (e.g., invasive species removal, assisting with prescribed fire, maintaining infrastructure such as fence or parking lots, and assisting with long-term wildlife monitoring activities such as bird banding or CWD sample collection). Pheasants Forever, Inc. is managing staffing and providing oversight with leadership and guidance on activities from DNR. The DNR will provide these specialists with any necessary training, equipment, and safety gear needed to perform their functions as well as facilitate collaboration with DNR field staff.

Selection Process Summary: Development of agreements is authorized under Iowa Code section 455A.4(6) and 456A.24.



12.1 Black Hawk Marsh WMA, Dike Repair - Sac County

The Department requests Commission approval of the following construction project:

Project Summary: The Black Hawk Marsh wildlife management area covers over 2,000 acres and consists of marsh, timber, and upland wildlife habitat which provides for multi-use outdoor recreation. The WMA is located approximately 7 miles south of Sac City and is adjacent to Black Hawk State Park.

The main dike for the marsh was constructed in 1993. Over the years, muskrats have burrowed voids in the dike, causing uneven settlement and damage to approximately 4,000 feet of the dike. This project will



remove and recompact the dike soils. The Sac County Conservation Board is responsible for removing and replacing the existing concrete trail that runs along the top of the dike.

12.2 Rock Creek State Park, Shoreline Stabilization – Jasper County

The Department requests Commission approval of the following construction project:

Project Summary: Located about 6 miles northwest of Kellogg, Rock Creek State Park is approximately 1,697 acres in size, and was dedicated in 1952. The 175-site campground borders the lake and includes electrical hookups and modern restrooms. The park offers trails to accommodate a wide variety of activities, including hiking, horseback riding, cross country skiing, and snowmobiling.

The lake experiences periods of high turbidity and low visibility due to shoreline erosion and resuspension of solids due to wave action. Many of the areas experiencing wave-action erosion have never been armored. This project will armor approximately 17,685 linear feet of shoreline with rock revetment.

12.3 Rathbun WMU, Road Maintenance – Appanoose, Lucas and Wayne Counties.

The Department requests Commission approval of the following construction project:

Project Summary:

The Rathbun Wildlife Management Unit (WMU) is located in 5 different counties – Clarke, Lucas, Monroe, Wayne and Appanoose. These 5 counties contain 17 different Wildlife Management Areas, and compromise of 29,407 acres of habit. This habitat includes: lake, timber, upland, ponds and marsh. The diversity of these areas attracts hunters, anglers, hikers, backpackers, bird watchers, horseback riders, mountain bikers.

This project includes 5 different roads throughout the Rathbun WMU. One road is the only access to Browns Slough and two of the roads provide launch access to Rathbun Lake. The road to the HQ building will need one culvert dug up and pinned back together due to separation. The separation is causing erosion of the roadway embankment. Roadway blading, shaping and additional rock will be added. The second road will have a rusted-out CMP culvert replaced by an RCP culvert with footing. Erosion stone and rip rap will also be added at the inlet and outlet to prevent future erosion. Blading, shaping and additional rock will complete this road. The third road will be bladed, shaped and have additional rock placed. The fourth road will need brush cleared out of the ROW ditches and have additional rock placed after blading. The fifth road will have some minor ditch cleaning to improve drainage, a rusted-out CMP culvert replaced with an RCP culvert. Erosion stone and rip rap will be place at the inlet and outlet as well. Roadway blading, shaping and the addition of rock will complete the work on this road.

13. Public Land Acquisition Project

13.1 Muskrat Slough Wildlife Management Area, Jones County – Eastern Iowa Conservation Foundation

The Natural Resource Commission's approval is requested to purchase a tract of land located in Jones County adjacent to Muskrat Slough Wildlife Management Area (WMA).

Seller: Eastern Iowa Conservation Foundation

Acreage: 13.27 acres

DNR Purchase Price: \$30,000 **Appraised Value**: \$80,300


Property Description: This tract is an inholding within Muskrat Slough WMA located 4 miles west of Olin. Although small, this tract is a critical inholding on the public land complex. Acquisition of the tract resolves access issues that arise from the tract being privately owned. It also provides a high-quality forest component to the WMA, which is limiting factor. The tract has numerous majestic, old-growth bur oaks present, and surprisingly, more recent regeneration of younger age classes of bur oak. Based on historic aerial photography this tract has been timber/oak savanna since before the 1930's. Black cherry, hackberry and some walnut also exist in the stand.

Purpose: The site has great potential to be restored to an oak savanna or open oak woodland state, with potential to restore the herbaceous ground layer to native prairie species. This could benefit Rusty Patch Bumble Bee (Federally Endangered) and other pollinators, herptiles such as Eastern gray treefrog, Smooth green snake (State Species of Special Concern), and Western fox snake, birds such as the Baltimore oriole and Red-headed woodpecker, the Least shrew (State Threatened) and numerous game species. This site will be open to public hunting and other outdoor recreation opportunities.

DNR Property Manager: Wildlife Bureau

Funding Source(s): \$30,000 Wildlife Restoration Federal Land Grant, \$50,300 Donated Value

Incidental Costs: Incidental closing costs will be the responsibility of the Department.



13.2 Wapello Bottoms Wildlife Management Area, Louisa County – Loren W. Humphrey Revocable Trust

The Natural Resource Commission's approval is requested to purchase a tract of land located in Louisa County adjacent to Wapello Bottoms Wildlife Management Area (WMA).

Seller: Loren W. Humphrey Revocable Trust

Acreage: 25.66 acres

DNR Purchase Price: \$25,000

Property Description: This tract is an Iowa River island, just west of the Wapello Bottoms WMA (Roudybush tract), located one mile north of Wapello. This island has limited access and thus has limited potential for management.



14.1 Chapter 17 Barge Fleeting Lease Renewal - Mississippi River, Louisa County

The Natural Resource Commission is requested to approve the renewal of Chapter 17 Barge Fleeting Lease, No. 45-R, with Matteson Marine Service, Inc of Burlington, IA.

Location: The leased area is described as a portion of the Mississippi River bed including approximately 600 feet of frontage by 100 feet of depth located at Mississippi River Mile 427.7 in Louisa County, Iowa.

Site Purpose: This area has been under a barge fleeting lease since 1988. A Public Notice was printed in a local newspaper and no comments were received.

Lease Fee and Term: The annual fee is \$2,712.00 and will be increased annually based on the percentage increase of the consumer price index. The term of the lease will be five years.

14.2 Chapter 17 Barge Fleeting Lease Renewal - Mississippi River, Louisa County

The Natural Resource Commission is requested to approve the renewal of Chapter 17 Lease No. 102-R with Matteson Marine Service, Inc of Burlington, IA.

Location: The leased area is described as a portion of the Mississippi River bed including approximately 1600 feet of frontage by 175 feet of depth located at Mississippi River Mile 430.3 in Louisa County, Iowa.

Site Purpose: This area has been under a barge fleeting lease since 1988. A Public Notice was printed in a local newspaper and no comments were received.

Lease Fee and Term: The annual fee is \$12,656.00 and will be increased annually based on the percentage increase of the consumer price index. The term of the lease will be five years.

14.3 Management Agreement Renewal, Middle Raccoon River Access – Guthrie County Conservation Board

The Natural Resource Commission is requested to approve a Management Agreement renewal with the Guthrie County Conservation Board for the Middle Raccoon River Access located in Guthrie County.

Location: This property is located 3 miles west of Linden in Section 15, Township 79 North, Range 30 West of the 5th P.M. in Guthrie County, Iowa. This access is within the Middle Raccoon WMA.

Site Purpose: This 1-acre property has a boat ramp that is used for boat access to the Middle Raccoon River.

Management History: This property has been under a management agreement with Guthrie County Conservation Board since 1999. The previous Management agreement expired December 2023.

Management Agreement Term: 25 years

This agreement was approved by the Guthrie County Conservation Board on April 10, 2024.

14.4 Management Agreement, Wood Duck Bottoms WMA – Linn County Conservation Board

The Natural Resource Commission is requested to approve the Management Agreement with the Linn County Conservation Board for Wood Duck Bottoms Wildlife Management Area located in Linn County.

Location: This property is located 4 miles south of Center Point and 2 miles east of Pleasant Creek State Park in Section 24, Township 85 North, Range 8 West of the 5th P.M. in Linn County, Iowa. This small parcel is adjacent to a 138 Linn County WMA.

Site Purpose: This 10-acre property is used for public access to hunting and other outdoor recreation activities.

Management History: This property has historically been managed by the DNR. Linn County recently purchased a 138-acre adjacent property making the County's management of the WMA sensible.

Management Agreement Term: 25 years

This agreement was approved by the Linn County Conservation Board on February 26, 2024.

14.5 Flowage Easement - Jared and Jennie Randles - Coal Creek Marsh, Warren County

The Natural Resource Commission is requested to approve the acquisition of a permanent flowage easement from Jared and Jennie Randles to the DNR as part of the creation of Coal Creek Marsh at Red Rock Lake, Warren County, Iowa.

Project Description: The DNR is constructing a water control structure across Coal Creek, north of HWY 5, to create a marsh for waterfowl habitat. The marsh is expected to be dry in the spring and summer and will be filled by Coal Creek at or below 762 feet above mean seal level (msl) to create an 800-acre wetland for migrating waterfowl in the fall.

The 1.23-acre permanent flowage easement will allow for the flooding portions of the Randles' property when the marsh is at capacity.

Compensation: \$7,500

14.6 Property Conveyance – Springbrook WMA - Guthrie Co. - Fidler

The Natural Resource Commission is requested to approve a property conveyance (Quit Claim issuance) located at Springbrook WMA, Guthrie County.

Grantee: Deanna L Fidler and Ricky D. Fidler

Acreage: 0.537 acres

The Springbrook Wildlife Management Area, containing approximately 563 acres, is located 10 miles northwest of Panora in Guthrie County. In 1998 the state acquired this 563-acre parcel from Central Iowa Energy Company. At the time of the purchase, the adjacent property was owned by Roy Middleton. A boundary fence was in place and observed as the correct boundary by all parties. Additionally, a garage, a portion of a house and a driveway existed on what turned out to be part of the property acquired by the State of Iowa / DNR. For the past 26 years the fence has been assumed to be the correct boundary. In 2020, the property was transferred from the Roy Middleton Estate to his daughter Deanna (Middleton) Fidler. Ms. Fidler is currently trying to sell their property and during their title examination process, this boundary issue was discovered.

This Quit Claim Deed would move the State's ownership to the fence that is currently recognized as the state boundary.

The state has the ability to issue a Quit Claim Deed per Iowa Code Chapter 9G.10 – Quitclaim deeds. "Whenever the governor is satisfied by proper record evidence that any tract of land which may have been deeded by virtue of any donation or sale to the state is not the land intended to have been described, and that an error has been committed in making out the transfers, in order that such error may be corrected, the governor is authorized to quitclaim the same to the proper owner thereof, and to receive a deed or deeds for the lands intended to have been deeded to the state originally."

Commission approval is requested for a contract with Stantec Consulting Services, Inc., of Independence, Iowa.

Contract Terms

Amount: Not to exceed \$48,000 **Dates**: May 9, 2024 to May 1, 2026

Funding Source(s): Federal Grant (Cooperative Endangered Species Conservation Fund Section 6 of the Endangered

Species Act)

Contract Purpose: The purpose of the contract is to conduct a study to assess the current status of the Upper Wapsi population of eastern massasauga rattlesnake (Sistrurus catenatus; EMR), its habitat use and availability, and risks to the species. The EMR was listed by the U.S. Fish and Wildlife Service (USFWS) as a threatened species under the Endangered Species Act in October 2016. Recovery of the EMR is reliant upon conservation partners implementing actions intending to address populations declines and increase knowledge/understand of the species as described in the Recovery Plan for Eastern Massasauga Rattlesnake.

There is a need for the Department of Natural Resources (DNR) to collect EMR population information in order to effectively plan for and implement actions important for species recovery in Iowa. Understanding the current status of EMR, knowledge of its habitat use and availability, and risks to the species, are important considerations for developing management plans to implement effective conservation actions focused on recovery in the state. This study will monitor one of the only two known remaining populations in Iowa for comparisons with the work done in the early 2000s by the same consultant. The DNR intends to use this information for conservation and management planning.

Contract tasks include:

- A telemetry study monitoring up to five EMR through the use of radio telemetry to collect microhabitat and snake activity information. Radio-tagged specimens will be tracked throughout the 2024 active season until they enter hibernation. Radio tracking will begin again early in spring of 2025 in an attempt to determine when the snakes emerge from hibernation.
- Habitat assessment to assess summer and winter habitat conditions and evaluate habitat quality within activity range and surrounding areas.
- Risk assessment to identify and evaluate potential risks to the population.

Selection Process Summary: The Department solicited proposals from targeted small businesses and also published a Request for Proposal (RFP) on the Department of Administrative Services website.

Commission approval is requested for a contract with Houston Engineering, Inc., of Omaha, NE.

Contract Background: Lake Manawa is a natural oxbow lake located within Council Bluffs, Iowa. Manawa is over 1,500 acres in size, and supports various forms of recreation, including fishing, paddle sports, power boating, and swimming. Much of the eastern shoreline is in private ownership.

In 1955, the Mosquito Creek diversion structure was constructed with the intent of providing a water source to the lake during dry periods. The diversion structure includes a roller dam on Mosquito Creek. Valves can be manipulated to divert water through an approximately 1.5 mile long, 48-inch diameter reinforced concrete pipe to the outlet point located on the eastern shore of Lake Manawa. According to historical documents, the last twenty feet of pipe is corrugated metal. Currently, a significant amount of flow is coming from the joint between the concrete pipe and the metal pipe due to a structural failure.

This project consists of replacing the corrugated metal pipe with a reinforced concrete pipe. The park and lake are one of western lowa's premiere spots for outdoor activities and maintaining the water levels through the Mosquito Creek diversion pipe is important to the community and recreational users. This structure is critical piece of infrastructure used to maintain pool elevation in the Lake.

Contract Purpose: The DNR is entering into this Contract with Houston Engineering, Inc., an engineering consulting company, for the design for the replacement of the Mosquito Creek diversion pipe outlet.

The selected firm will prepare final designs, including drawings, specifications, and cost estimates. The firm will be responsible for conducting needed site surveys, investigations, prepare bid documents, addenda, answer prebid questions, conduct one on-site preconstruction meeting, and will also be retained during construction to assist with plan and construction clarification.

Selection Process Summary: The department solicited proposals from targeted small businesses and published a Request for Proposals (RFP) on the Department of Administrative Services website.
