### 7. Contract with Ducks Unlimited Inc. (Riverton)

Commission approval is requested for a contract with Ducks Unlimited, Inc. (DU), of Dexter Michigan.

#### **Contract Terms:**

Amount: Not to exceed \$385,000 **Dates:** May 15, 2023 to August 15, 2023

Funding Source(s): Federal NAWCA (\$100,912), Fish and Wildlife Trust Fund (\$284,088)

Contract Purpose: Riverton WMA is located in the floodplain between the East and West Forks of the Nishnabotna Rivers in Fremont County, Iowa. Historically, the project site was a vast wetland complex that supported huge numbers of waterbirds during spring and fall migrations. Hydrologic modifications to this floodplain, including channel straightening and extensive tile drainage systems throughout the watershed, have modified the historic hydrology and greatly reduce the quantity and quality of wetland habitat in the area. Incised, channelized river beds make it difficult to flood the wetlands. Conversely, extensive upstream drainage systems result in extreme flood events on an ever-increasing basis. These flood events also result in excessive silt deposition in natural oxbows and water conveyance ditches on the wildlife area. Today, many parts of the wildlife area hold water for too long after these flood events, killing floodplain forests and promoting monotypic stands of undesirable vegetation such as river bulrush and reed canary grass.

In an effort to reverse this trend and help meet their goal of providing high quality wetland habitat for migrating waterfowl, shorebirds and wading birds, Iowa DNR is undertaking steps to improve water management on Riverton WMA. The first step was to assess current conditions and issues affecting the wildlife area. In July 2018, Iowa DNR and Ducks Unlimited hosted a wetland review on the wildlife area. Over 30 wetland biologists and management specialists from numerous state and federal agencies, universities and NGO's met for 2 days to assess current conditions and provide recommendations to improve seasonal wetland habitat on the area. The primary recommendation of this plan was to improve the water management infrastructure to better replicate natural, historic hydrologic conditions. This grant proposal is the first step in implementing these recommendations.

In order to accommodate the frequent flooding the wetlands have experienced, DU engineers will improve the water management system on the wildlife area. The component this contract will address will be replacing an undersized outlet structure in the North Refuge Unit. The existing 48" structure is too small to accommodate drainage from the 3,000 acre watershed and will be replaced with a 72" structure will improve management capabilities. Waterfowl counts during peak migration regularly exceed 30,000 mallards on the North Refuge, and improving water management is expected in increase this number.

## DU tasks associated with this contract include:

- Construction Management: Provide construction management inspection services to confirm all site developments are completed in a timely manner.
- Construction Check Out: Review and verify as true and correct all invoices.

### For this project, DNR tasks include:

- Design and Construction Input: Routinely inspect the construction site when any construction is in progress, and keep DU advised of any desired changes, additions, or deletions to the project construction.
- Site Management: DNR shall manage the site to provide habitat that is beneficial to migratory birds in conformance of NAWCA U.S. Grant Administrative Standards.

Amendment Purpose: To print and distribute 115,000 copies of the 2023-2024 lowa Hunting, Trapping, and Migratory Game Bird Regulations to over 800 vendors, businesses, government agencies, and DNR offices in and around lowa for the public's use. This amendment will provide the same services as previously contracted. Increase in cost has been seen industrywide as the price of wood pulp has increased significantly since 2020, and those costs are being passed along by the papermakers and the printing industry.

**Original Contract Purpose:** In 2019, The Iowa DNR selected Liberty Press LLC to print and distribute copies of the 2019-2020 Iowa Hunting, Trapping and Migratory Game Bird Regulations to vendors, businesses, government agencies, and DNR offices in and around Iowa. The Department produces this rules and regulations booklet annually. The 2019 printing was the third year the DNR combined the waterfowl regulations into the Hunting and Trapping regulations book which coordinates with federal waterfowl information and provides cost and time savings in printing and distribution. Positive comments have been received by users regarding the convenience of having the information in one publication.

As outlined in standards, all paper types contain post-consumer waste and are recyclable. Liberty Press LLC has provided a quality product using 40# Electracote SCB Grade paper. This grade of paper was used for the 2018 regulations and users provided positive comments on its quality and durability, especially with the longer time hunters and trappers can use the combined publication (August – May). Also, this type of paper grade is more attractive to advertisers purchasing ad space in the publication. For printing, the DNR will provide the print copy and shipment list with quantity per location to the contractor. The contractor will provide a print proof for approval prior to production printing, make any revisions, print 175,000 copies, and pack and distribute cartons per the shipment list. (In 2021, the print quantity was reduced to 150,000 copies due to fewer regulations being picked up by the hunters as more are downloading the electronic version to their phones and computers. It was reduced again in 2022 to 125,000 copies, and again in 2023 to 115,000 copies.)

**Original Selection Process:** The Department solicited proposals from targeted small businesses and published a Request for Proposal (RFP) on the Department of Administrative Services website. Proposals were reviewed based on the criteria as described in the RFP which included their ability to complete the scope of work within the desired timeline, quality of product, and description of previous and applicable work experience.

### \*11. Publicly Owned Lakes Watershed Eligibility Program- FY24

### Purpose:

This process establishes a priority list of watersheds above significant public lakes where private landowners are eligible to receive cost-share moneys to establish soil and water conservation practices. Funds for these practices are set aside in appropriations to the Department of Agriculture and Land Stewardship (IDALS).

In order to be eligible to receive IDALS's Publicly Owned Lake (POL) Program funds, an applicant must be a soil and water conservation district and submit an application for POL priority designation to IDALS - Division of Soil Conservation. Applications are submitted annually, as specified by in writing, to the Division. The Division then forwards applications to the Department for determination of program eligibility.

The Department reviews applications based on compliance with application requirements. For example, the application requests a map of the watershed identifying the sources and estimated sediment delivery to the lake; and, description, location, estimated costs and estimated reduction of sediment delivery for each planned practice that will be implemented pending program funding. The purpose is to target locations within the watersheds that contribute significant sediment to the lake for installation of permanent or management soil conservation practices.

**Summary of Selection Process:** As outlined in Iowa Administrative Code 571, Chapter 31, Public Owned Lakes Program, the DNR is responsible for the application review and recommendation process. The DNR is to then submit the recommended list of publicly owned lakes eligible under the program for the upcoming year to the Natural Resource Commission for approval. The Review and Selection Committee evaluated applications based on the criteria above.



### 15.3 Lake Wapello State Park, Office and Storage Building – Davis County

The Department requests Commission approval of the following construction project:

Project Summary: Lake Wapello State Park is located east of Unionville, and was opened to the public in 1936. Named after the famous Native American Chief Wapello, Lake Wapello State Park boasts a variety of outdoor opportunities. More than 1,000 acres of beautiful wooded hillsides offer scenic picnic areas, and the lake provides a relaxing atmosphere for activities such as canoeing, kayaking and fishing. The Lake Wapello beach house was built in the 1930s by the Civilian Conservation Corp and its pueblo style architecture makes it one of the most unique buildings in the state park system.



In the late 1950's, park staff converted a CCC horse barn to a shop and office, and have been using it in that capacity since. The interior of the structure is in need of renovation. Rather than renovate the existing structure, a new shop and office building will be constructed and the existing structure will be used as storage. The new shop and office building will be constructed of Structural Insulated Panels (SIPs), covered in steel siding and asphalt shingles. The storage/shop area will have three heated bays. The office portion of the building will consist of a shared office, breakroom, and restroom. The main entrance to the building will have a design-guide heavy timber truss overhang.

### 15.4 Lacey-Keosauqua State Park, 2023 Concrete Trail – Van Buren County

The Department requests Commission approval of the following construction project:

Project Summary: Lacey Keosauqua State Park consists of 1,653 acres of hills, bluffs, and valleys along the Des Moines River. Park facilities include a campground with modern restrooms and showers, six seasonally open modern cabins, two picnic shelters, two lodges, and a 30-acre lake.

Currently there are no pedestrian or bicycle accommodations from the campground to the beach. Campers must either drive or walk along a busy rural road. This project will provide an ADA accessible route from the campground to the beach and cabins.



Lacey-Keosauqua's Friends Group has provided funding support for various projects within the park and will be donating the funds for this project. As part of the agreement, the Friends Group has asked for Cole Construction Co, Inc., a local contractor, to complete the project. The DNR has successfully worked with Cole Construction on other projects in the past.

### 15.5 Missouri River Wildlife Flood Repairs – Harrison, Monona, Shelby and Woodbury Counties

The Department requests Commission approval of the following construction project:

**Project Summary:** This contract addresses flood damage that occurred in six different wildlife management areas, Tyson Bend WMA, Rosenow Timber WMA, Deer Island WMA, Louisville WMA, Weedland WMA and Luton WMA. These areas are located along the Missouri River. Habitat in these areas consist of marsh, timber, forest, and upland. Popular game species include deer, turkey, squirrel, pheasant, waterfowl, rabbit, dove, and quail. These areas also provide boat access to the Missouri River.

Flooding in 2019 damaged multiple wildlife areas. Roads, parking lots, a water control structure, and a wetland pumping station were damaged. Road and parking lot repair work consists of filling in scour holes, removing deposited sediment, tree debris

removal, and placing new rock surfacing on two miles of road. Water control structure repairs consist of replacing damaged safety railing, and resetting a foot bridge. Pump station repairs consist of replacing all electronic equipment, the mechanical pumps, and the river-side sluice gate.

#### **Contract Terms**

**Amount**: Not to exceed \$163,266.00 **Dates**: 1/1/2023 to 12/31/2025

Funding Source(s): Federal USFWS Competitive State Wildlife Grant

Contract Purpose: This three-year agreement is part of a Federal grant in which Iowa, Nebraska, Missouri, and Minnesota are cooperating to develop a community science program referred to as the Midwest Bumble Bee Atlas. As pollinators, bumble bees are essential contributors to the health of ecosystems in Iowa and across the Midwest, but there is alarming evidence that bumble bee populations are declining. There is a need for a regionally comprehensive bumble bee monitoring program to fill knowledge gaps in current distribution, site occupancy, and habitat associations of bumble bees. Outcomes of this project will be increased understanding of the status and habitat needs of these essential pollinators, greater awareness of the Species of Greatest Conservation Need (SGCN), and evidence-based conservation recommendations. By engaging the public, this program will help to build a network of volunteers that can help monitor bumble bees using a model that has been successfully used in the Pacific Northwest.

This subaward is for Iowa State University to provide the service of conducting research on bumble bee use of sites enrolled in Conservation Reserve Program and established in certain conservation practices designed to benefit pollinators. In addition, ISU will assist other project partners with completion of bumble bee surveys, with overall project coordination, and with providing training workshops and outreach presentations.

**Selection Process Summary:** Iowa State University partnered with four states to develop a federal grant proposal which was selected for funding by the U.S. Fish and Wildlife Service. This is a sub-recipient award for the portion of the project which Iowa State University committed to completing for Iowa. Development of agreements is authorized under Iowa Code section 455A.4(6) and 456A.24.

Amendment Purpose: Honey Creek Resort underwent a condition assessment in the fall of 2022. Deferred maintenance needs were identified at that time. DAS and the new concessionaire agreed that the State would provide funding for and take lead on addressing the deferred maintenance that pre-dated the new concessionaire's operation. DNR and DAS's recently-approved 28E for Honey Creek Resort needs to be amended to account for DNR transferring funds to DAS for this purpose. The funding comes primarily from a just-approved Honey Creek Resort special appropriation, with a small balance coming from State Parks infrastructure dollars.

DNR shall provide funding to DAS for the deferred maintenance. DAS shall oversee and manage the deferred maintenance needs over the next two to three years using these funds.
