



# 2019 REAP Assembly Report

During the November and December 2019, 18 Resource Enhancement and Protection (REAP) Assemblies were conducted throughout Iowa. The REAP Assemblies are required, per Iowa Code Chapter 455A.17, to be conducted on odd numbered years to provide attendees with information about REAP expenditures, ask attendees to identify opportunities or changes in policy, programs or funding, vote on motions for the five elected delegates per region to vote on at REAP Congress. 611 Iowans participated in the 2019 REAP Assemblies. In addition to electing delegates, the participants made 77 motions that will be forwarded to the REAP Congress for consideration on January 4, 2020.

**The following motions were approved at the Assemblies.** The number behind the motion indicates the number of Assemblies at which it was approved. Bolded items were approved at 10 or more Assemblies.

- 1) **This REAP Assembly recommends that the 2020 REAP Congress supports fully funding REAP at \$20 Million. 14**
- 2) This REAP Assembly recommends that the 2020 REAP Congress supports fully funding REAP at \$30 Million. 2
- 3) **This REAP Assembly recommends that the 2020 REAP Congress supports keeping the REAP formula the same. 14**
- 4) **This REAP Assembly recommends that the 2020 REAP Congress supports fully funding the Natural Resources and Outdoor Recreation Trust Fund through the passage of a 3/8th of a percent increase of Iowa's statewide sales tax. 10**
- 5) This REAP Assembly recommends that the 2020 REAP Congress recommends keeping the IWILL formula the same as 2010. 4
- 6) This REAP Assembly recommends that the 2020 REAP Congress supports fully funding the Natural Resources and Outdoor Recreation Trust Fund through the passage of a 3/8th of a percent increase of Iowa's statewide sales tax, including keeping the current formula intact, including fully funding REAP. 6
- 7) This REAP Assembly recommends that the 2020 REAP Congress support extending the REAP sunset to the year 2041, unless IWILL is fully funded with REAP in its existing form within the currently set IWILL formula. 1
- 8) This REAP Assembly recommends that the 2020 REAP Congress recommends fully funding IWILL and not replace any current natural resources funding. 2
- 9) **This REAP Assembly recommends that the 2020 REAP Congress supports eliminating the REAP sunset date. 13**
- 10) This REAP Assembly recommends that the 2020 REAP Congress supports extending REAP for 30 years beyond the 2021 sunset date. 3
- 11) This REAP Assembly recommends that the 2020 REAP Congress recommends continuing REAP for 50 more years. 1
- 12) This REAP Assembly recommends that the 2020 REAP Congress recommends extending REAP language for at least 15 years. 1
- 13) This REAP Assembly recommends that the 2020 REAP Congress recommends that the REAP sunset be extended to 2036. 1

- 14) This REAP Assembly recommends that the 2020 REAP Congress recommends increasing the program authorization to \$40 Million to account for inflation for the past 30 years. 1
- 15) This REAP Assembly recommends that the 2020 REAP Congress recommend that funding and support of Watershed Management Authority and Coordinators in the state. 1
- 16) This REAP Assembly recommends that the 2020 REAP Congress recognizes the value of outdoor recreation in Iowa. 1
- 17) This REAP Assembly recommends that the 2020 REAP Congress recommends that the Legislature look at additional funding sources, other than gaming revenue. 1
- 18) This REAP Assembly recommends that the 2020 REAP Congress recommends allowing cities, county conservation boards, state and non-profits to be able to acquire land in Open Spaces for the people of Iowa to maintain a quality of life. Public land is very important to Region 8. 1
- 19) This REAP Assembly recommends that the 2020 REAP Congress recommends forming four city categories with input from smaller towns. 1
- 20) This REAP Assembly recommends that the 2020 REAP Congress recommends that the DNR works with County Conservation Boards to identify environmentally sensitive areas of the state. 1
- 21) This REAP Assembly recommends that the 2020 REAP Congress recommends that conservation education funds be increased and remain taken off the top. 1

Additionally, participants at each assembly broke into small groups to discuss the most significant things REAP has done in their communities, positive and negative impacts and then a vision for the next five years. They listed and discussed hundreds of ideas, recommendations and impacts. They are listed by region in the Assembly Summary later in this document.


