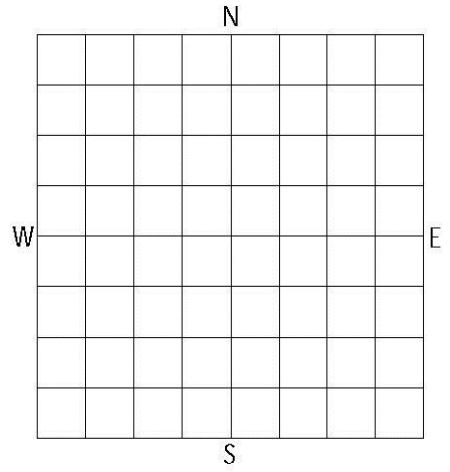

1. **If not previously submitted, provide evidence of the applicant's legal authority to drill and/or operate on the property. Provide the applicant's detailed plan for disposal of drill cuttings, mud, waste water and any other anticipated waste streams.**
2. **Provide the applicant's plan for plugging wells.**
3. **Provide the applicant's plan for protecting groundwater, aquifers and/or nearby waters of the state.**
4. **Drilling operations may be subject to air permitting regulations. The applicant must contact DNR's air permitting section to obtain all necessary air permits prior to commencing operations. The drilling permit will not be issued until the DNR air permitting section provides its approval.**
5. **Storm water runoff from drilling operations is not subject to permitting in most situations. However, the applicant should contact the DNR's NPDES permitting section to determine if a permit is necessary for the operation.**

INSTRUCTIONS

The requirements below apply generally to all wells drilled in the state of Iowa. See 565 IAC 51.2(1) (production wells) or 51.2(2) (stratigraphic wells) to determine which documents must be included with your application.

File one copy of this form and all supporting documentation with the DNR, Attention: Land Quality Bureau Chief (address below).

An organization report must be submitted to the Land Quality Bureau Chief if not already on file. The report may accompany the application.

A bond must be submitted to the Land Quality Bureau Chief if not already on file. The bond may accompany the application.

An accurate plat, map, or sketch prepared by a competent surveyor or engineer must be attached to this application. The plat shall be drawn neatly and to scale, and must show the distance from the two nearest lease and section lines and from the nearest wells on the same lease completed or drilling.

An elevation above sea level datum determined by a competent surveyor or engineer shall appear on the application at the time it is submitted.

For production wells, the permit fee in the amount of \$50.00 per well made payable to the Iowa Department of Natural Resources must accompany the application. For stratigraphic test wells, the permit fee in the amount of \$200 -- regardless of the number of wells proposed -- should be included with the application.

NOTE: The Iowa DNR will review all submitted documentation and grant or deny a drilling permit. If the information submitted is deemed insufficient by the DNR, additional information may be requested prior to a permit being issued. Absolutely no drilling may occur until a permit is issued. The DNR retains the right to inspect a site prior to or during drilling or operation.

“Operator” shall mean any person who, duly authorized, is in charge of the development of a lease or the operation of a producing well.
