The condition of this obligation is that whereas the above bounden principal proposes to commence and prosecute to final
completion a well or wells for oil or gas, secondary recovery, disposal of salt water, brine, or other oil field wastes, storage of dry
natural gas or liquid petroleum gas, or for geological information in and upon the following described land situated within the State,
to wit:

NOW, THEREFORE, if the above bounden principal shall fully comply with all of the provisions of Iowa Code Chapter 458A, as
amended, and the rules, regulations and orders of the Iowa Department of Natural Resources and the Director, especially with
reference to the proper plugging of said well or wells, and filing with the State Geologist all notices and records required by said
Department, and the restoration of the surface, in the event said well or wells do not produce oil or gas in commercial quantities, or
cease to produce oil or gas in commercial quantities, then this obligation shall be terminated by the Director, otherwise the same
shall be and remain in full force and effect.

INSTRUCTIONS

File three copies of this form with the State Geologist. If you wish approved copies for your files, these should be submitted in addition to the three copies to be retained.

The bond shall be by a competent corporate surety authorized to do business in Iowa.

The term "plugging" as used herein is intended to include the filling of pits and the reasonable restoration of the site. Before the bond will be terminated the site will be inspected by the proper authority. Only after the site has been approved, and all records concerning the operation have been filled will the surety be given clearance to terminate its liability.

The bond shall be in the amount of fifteen thousand dollars (\$15,000) for a single well, and in the amount of thirty thousand dollars (\$30,000) as blanket bond for all wells drilled in the state by the principal.
