An annual tag listing "April 1, 2024" or "April 1, 2025" is required to receive fuel for tanks greater than 1100 gallons. The annual tag listing "April 1, 2024" must be on a UST fill ports to receive fuel deliveries.

If asked to deliver fuel to UST without current tags, obtain a copy of the authorization for your record, or contact the IDNR for assistance.
