Subject: Delivery Prohibition to UST Sites that Have Not Been Issued Annual Tank Management Tags

Dear Fuel Transport Companies:

On the UST Section website, <http://www.iowadnr.gov/InsideDNR/RegulatoryLand/UndergroundStorageTanks/USTEnforcement.asp>, also (www.iowadnr.gov/UST) under "Notices" there is a list of sites under delivery prohibition. As of April 1, 2015, these underground storage tank sites are prohibited from fuel deliveries. Tank tags have not been issued for the tanks due to non-payment of 2015 tank management fees, pending compliance issues, or temporary closure. Additionally, the list includes tanks that have been red tagged and remain under a delivery prohibition.

The deadline for 2015 tank tags to be attached to tank fill ports was April 1, 2015. The new tags are **blue and expire April 1, 2016**. Fuel delivery is prohibited to underground storage tanks that do not have current tank tags affixed to fill ports. Do not deliver fuel to the underground storage tanks that do not have current tank management tags unless written authorization has been issued by the Iowa DNR.

The list of delivery prohibition sites is a "snapshot of the site" this date. The DNR intends to update the list whenever situations change, i.e., as the delivery prohibition items are resolved by the owner/operator. The department has notified each of the owner/operators on the list of the intent to enforce delivery prohibition or "Red Tag" the tanks. Deliveries are prohibited until such time the tank management fee is paid in full, and/or compliance items resolved.

The sites under Delivery Prohibition enforcement may or may not have a Red Tag attached to the fill port. Remember, look for the **blue** tag on the fill port; if it is not present do not transfer fuel. If the site name is on the enclosed list, delivery is prohibited with or without the red tag.
