8		Clinton	41.811306	-90.791973	Steines Marsh. Large shallow wetland pond on the south side of the lane. Private land and lane. Used with permission. Stay on the lane.
9		Clinton	41.781204	-90.782349	Sherman Park Marshes. Open Woodland marshes and sedge meadows. Park in the lot, take trail 75 yards north then 100 yards east. Owned and Managed by Clinton Co. Conservation.
10		Clinton	41.779376	-90.67505	Duke Prairie. A native, wet prairie on the west side of the gravel road. Owned and Managed by Clinton Co. Conservation.
