What Types of Projects are NOT eligible for REAP Funding?

Funds are not available for single or multipurpose athletic fields, baseball or softball diamonds, tennis courts, golf courses, and other organized sport facilities. Swimming pools and playground equipment, frisbee golf, and dog parks are also ineligible.

City Parks & Open Spaces

Three (3) city size categories and grant amount ceilings have been established to assure grants are distributed to all sizes of cities. The amount of REAP grant money available to a city depends on population. Population numbers are derived from data reported via the last US Census, currently [2020 Census Data](#). The population categories and respective grant amount ceilings are shown below:

Population	Maximum
0-1,000	\$50,000
1,001 - 5,000	\$75,000
5,001 -10,000	\$100,000
10,001 - 25,000	\$125,000
25,001 - 50,000	\$150,000
50,001 - 75,000	\$200,00
Over 75,000	\$300,000

Applications that are funded, must be completed within two years of the grant award. 90% of funds can be requested at the time a grant agreement is signed and the remaining 10% will be awarded upon successful completion of the project. If this award is to be used as matching funds for other state and/or federal grants that information should be included in the grant narrative. Applications are due on August 15th, or the closest day to August 15th if it falls on a weekend, each year.

County Conservation

Counties are eligible to receive these funds if they are dedicating at least 22¢ per \$1,000 of the assessed value of taxable property in the county for county conservation purposes. In other words, a county must be committing a specified tax levy amount from county tax dollars to conservation in order to receive their REAP County Conservation funding.

Applications that are funded, must be completed within two years of the grant award. 90% of funds can be requested at the time a grant agreement is signed and the remaining 10% will be awarded upon successful completion of the project. If this award is to be used as matching funds for other state and/or federal grants that information should be included in the grant narrative. Applications are due on August 15th, or the closest day to August 15th if it falls on a weekend, each year.

Conservation Education

The Conservation Education Program (CEP) is a key provision of the Resource Enhancement and Protection (REAP) Act of 1989. \$350,000 is allocated annually for formal and non-formal education projects and programs

through competitively awarded grants and cooperative agreements. Applicants can apply for funding that supports hands on interactive types of educational experiences (ie. workshops, trainings, field trips, classroom activities) or passive education experiences (ie. interpretive or wayside signs, brochures or video programming, education center exhibits).

***NOTE* This grant opportunity is currently moving through an Administrative Rules Update with no clear dates for grant submittal in calendar year 2025 at this time. Once Rules are approved, notice will go out to inform interested parties of the new application deadlines. Deadlines previously used, May 15 and November 1, are a part of changes proposed in the new administrative rule submittal.**

Private Cost-Share Grants

One-tenth of the 28% of REAP Open Spaces Protection is set aside to cost-share land acquisitions with private organizations. The cost-share arrangement entails 75% of the acquisition costs coming from REAP and the other 25% coming from private contributions. This program provides an excellent opportunity for private conservation organizations to help provide outdoor recreation opportunities and protect critical habitat. The State of Iowa owns and manages the property that is jointly purchased on behalf of the public. Applications are due on August 15th, or the closest day to August 15th if it falls on a weekend, each year.
