Title V Emissions Fee Payment	July 1, 2026
Annual Compliance Certification (ACC)	March 31, 2026*
Semi-Annual Monitoring Report (SAMR)	*March 31, 2026 *& September 30, 2026**

* Required only if your initial Title V permit was issued prior to January 1, 2026.

** Required only if your initial Title V permit was issued prior to July 1, 2026.


DNR Air Quality Compliance Reporting News:
