Paragraph 101.502(4)"e" (current 102.15(4)"e") was changed from "Environmental monitoring" to "Combustion controls and monitoring" under the recommendation of DNR Air Quality. 				the primary chamber is important for proper incineration; monitoring of temperature in the secondary chamber (i.e. location of afterburner) is important to ensure that smoke and odors are destroyedwhich the DNR feels is better covered by "Combustion controls and monitoring." Paragraph 101.502(7)"b" (current 102.15(7)"b") was revised to update the location of the DNR's main offices, as well as to remove the 30-day timeframe for application for examination submission. To remove regulatory language, applicants just need to submit the application before they take the exam. Paragraph 101.502(7)"e" (current 102.15(7)"e") was revised to strike the 10-days timeframe for examination fee submission to the DNR. Again, to remove regulatory language, applicants just need to submit the examination fee before they take the exam. Paragraph 101.502(8)"a" (current 102.15(8)"a") was revised to strike the July 1, 1991 exemption. This date has long passed, and given there are no permitted solid waste incinerators in lowa, this division currently does not apply to anyone. Upon the permitting of such a unit, any operator shall be required to take the basic operator training course and pass the examination in order to become certified. Paragraph 101.502(9)"d" (current 102.15(9)"d") was revised to reduce the contact hours from 10 to 6 based upon a review of available incinerator trainings.
