6. Brass Bluegill Award and Special Recognition - 2022

Ken Carroll, Professor, Parks and Natural Resources at Kirkwood Community College in Cedar Rapids is the 2022 Brass Bluegill recipient. Since 2008, Ken has been a *Fish Iowa!* trainer, sharing the materials with his students. He includes *Fish Iowa!* in Applications of Natural Resources, a first year, first semester class. He also trains students in *Project WILD* and *Aquatic WILD* which help them develop interpretive skills and provides content material they will use when they complete the Certified Interpretive Guide Training through the National Association of Interpretation their final semester of the program.

Kirkwood's Parks and Natural Resources students are trained in ecological restoration and interpretive skills to help them secure jobs as naturalists, park rangers, park managers and conservation officers. Many transfer to four-year colleges and universities.

Carroll has trained some 450 future conservation professionals in *Fish Iowa!* and the WILD resources. According to him, "This pre-service training is invaluable as a resume builder. What we thought were soft skills of being able to communicate and lead really were a lot more important than that. These students are exposed to communication and presentation skills, and find strengths to talk about natural resources and practice those skills over and over to make an impression on a prospective employer in an interview or hit the ground running in their careers."

Students are fully immersed in the *Fish Iowa!* teaching module throughout the semester. They learn fishing knots, practice casting, create their own fish to learn about adaptations, and compete in a casting competition. Students often follow up by fishing in ponds on the Kirkwood campus.

One of Ken's students shared, "Ken is the organizer of several clubs on campus and teaches many types of classes, but I personally believe his true passion is teaching *Fish Iowa!*" Another said, "He has inspired generations of college students to get involved in fishing and teaching others."

The DNR's Aquatic Education Program success relies on local partnerships like the one we have with Mr. Carroll and Kirkwood that enable us to multiply our efforts by empowering future natural resources professionals to engage others through fishing and conservation education.

The Brass Bluegill award has been presented each year since 1996 to an outstanding local program that exemplifies the goals of the *Fish Iowa!* Angler Education program. Carroll will receive his award, along with fishing equipment to use with his classes.

***8. Contract with Pheasants Forever, Inc., and Iowa Native Seed Growers Association**

Commission approval is requested for a cooperative agreement with Pheasants Forever, Inc., of St. Paul, MN and with Iowa Native Seed Growers Association of Winterset, IA.

Contract Terms

Income: Approximately \$100,000 annually

Dates: July 1, 2022 to June 30, 2028

Funds Deposited to: Habitat Check-Off Fund

Contract Purpose: The purpose of entering into this Cooperative Agreement is to continue the partnership between the Iowa Native Seed Growers Association (INSGA), Pheasants Forever, Inc. (PF), and the Iowa Department of Natural Resources (DNR) to promote the creation and enhancement of native prairie habitat in Iowa. This agreement has been in effect since 2003 and has helped to facilitate a great partnership between DNR, PF, and INSGA.

The Habitat Check-Off funds are split 50:50 between PF and DNR, and donations to the fund are made when participating INSGA dealers/growers receive Habitat Check-Off Certificates, PF Seed Orders and Vouchers, and DNR Prairie Partner's Vouchers. Income deposited into the Habitat Check-off Fund may vary depending on the number of customers who use the Habitat Check-Off Program and the amount of their purchase. Revenues during the last agreement period (2016-2022) averaged ~\$100,000 annually. PF and DNR shall make use of the Habitat Check-Off Funds for the promotion, creation, and enhancement of native prairie habitat using both seed and/or plugs on private and public lands.

The partners work together to promote the Habitat Check-Off Program and maintain the Habitat Check-Off Fund. The majority of the funds in the Habitat Check-Off Fund have been used to provide cost-share to landowners to purchase native grassland plant material including seed or plugs. The funds have also been used for advertisement of the program and promoting the use of native plant materials in conservation practices.

The goal of this cooperative agreement is to facilitate conservation work on both public and private lands throughout Iowa by using native plant material in a manner acceptable to all parties to this agreement. All parties shall:

- Work together to implement a system that provides DNR access to native plant materials for the creation and enhancement of native prairie habitat.
- Work together to continue the program PF has put in place to purchase, deliver, sell, and distribute seed through its chapter's habitat programs.
- Work collaboratively to find new ways to promote the use of native plant materials and native seed and plant industry in Iowa.

9. Chapter 27 – Land and Water Conservation Fund, City and County Grant Recommendations (FY2022)

The Commission is requested to approve the following grant recommendations pursuant to Chapter 27, Land and Waters Conservation Fund, City and County Grant program.

Grant Purpose: The Land and Water Conservation Fund (LWCF) is a federally funded, fifty percent cost share, grant program. The purpose of LWCF is to offer grants to Iowa’s cities and counties to assist with acquisition and development of outdoor recreation. The program is governed by program rules adopted in Chapter 27 of the Iowa Administrative Code. The scoring criteria established in Chapter 27 include:

- Relationship to SCORP priorities (Statewide Comprehensive Outdoor Recreation Plan),
- Direct recreation benefits provided,
- Local need, and
- Quality of the site.

Also, as established by rule, bonus and penalty points are awarded based on criteria such as: level of prior assistance from the LWCF, special features for the elderly and persons with disabilities; minority populations served, degree of public participation and support, recycled content material use, and level of planning that has preceded the application for a LWCF grant.

Funding Source: U.S. Department of the Interior distributes the LWCF grant funds after their budget is approved, which is usually by the fall of the year.

Grant Funding Available: For this grant cycle (Federal Fiscal Year 2022), Iowa’s apportionment for distribution has not yet been allocated. We are expecting to receive the allocation later this summer, and to be in the range of \$1,500,000 to \$2,000,000.

Summary of Selection Process: As directed by criteria under Chapter 27, the grant review and selection committee met on May 5, 2021, to evaluate and score applications and to provide recommendations for the grant awards. Chapter 27 outlines that no application shall be selected which has received a score of less than 60.

Selection Committee Members: The review and selection committee consisted of five members:

- Iowa Association of County Conservation Boards (1)
- Iowa Parks and Recreation Association (1)
- DNR (3)

Number of Eligible Applications Received: 12

Recommendations: The Committee recommends funding the projects in the ranked order they are listed as funds are available. If a ranked project declines their award or an application is withdrawn, dollars will be offered to the next qualified applicant. Any unused funds will carry forward for use in future projects.

10. Contract with Iowa Regional Utilities Association

Commission approval is requested for a contract with Iowa Regional Utilities Association, of Grundy Center, IA.

Contract Terms

Amount: \$193,873

Dates: June 13, 2022 to December 30, 2022

Funding Source(s): Parks Infrastructure Fund

Contract Purpose: Rock Creek State Park in Jasper County is a premier camping destination in central Iowa, offering a variety of outdoor activities, including boating and paddling, year-round fishing, hiking, and horseback riding. Nearly 200 campsites comprise the park's beautiful campground, featuring both electric and non-electric sites, with several sites available on the water's edge or in wooded areas, and a modern restroom and shower building.

Currently, the Park utilizes a water cistern which is filled up using a ¾ inch water line coming into the Park. The cistern stores water during the week so there is water available and adequate pressure for the campground and park-wide use over the weekends. After the weekend depletion, the cistern then fills up again during the week. As usage increases, this is not ideal because the water cistern will not be able to hold enough water to meet the use levels at the park.

Also, the existing water cistern, approximately 55 years old, is in need of replacement due to its age and condition. Instead of replacing the cistern, this project will remove it from the water distribution system and instead have the water provider install a larger 6-inch water line coming into the park and a 2-inch water meter and pit. By installing adequate water supply lines, this will eliminate the need to shut down the campground and other uses at the park which would need to occur if we replaced the cistern. The increase in the line coming into the park will provide enough water flow and pressure to meet the park needs while also alleviating the long-term maintenance and certification requirements of maintaining a water cistern system.

Tasks for this contract include:

- Install approximately 8,300 feet of 6-inch water main coming into the park and a new 2-inch water meter and pit in the park.
- Connect 6-inch water main to an existing 2-inch water system in the park

Selection Process Summary: The Department utilized a sole source agreement with Iowa Regional Utility Association. The sole source agreement is needed because they are the water service provider for the park, they own the infrastructure, and they are the only provider in the area. Iowa law prevents multiple water supply utilities in a given area. The vendor's price quote was determined reasonable by comparing it to similar prior construction projects that were competitively bid.

11. Contract with Mitchell County Conservation Board (Cedar River Water Trail Access Improvements)

Commission approval is requested for a contract with Mitchell County Conservation Board (MCCB) of Osage, IA.

Contract Terms:

Amount: Not to exceed \$120,000

Dates: June 13, 2022 to June 30, 2024

Funding Source(s): Rebuild Iowa Infrastructure Fund (RIIF)

Background: During the recent water trail planning process, public input and the water trail steering committee (consisting of local citizens and public officials) identified Bennett, Spring Park, and T38 as high priority areas for improved river access and parking. All three access areas have no formal launches, just uneven (sometimes steep) natural paths down to the river's edge. Crushed limestone is used at T-38, but it's costly and maintenance intensive due to high water events washing the gravel downstream each year. Additionally, the river segment from Bennett to Spring Park has been identified as the most popular stretch on the Cedar in Mitchell County due to its scenic quality and close proximity to Osage, the largest city in the county.



The County Conservation Board, City of Osage, and the steering committee determined that the segment from Bennett to Spring Park was the best candidate for "Gateway" access treatment. The DNR agrees. Gateway accesses mean they will incorporate "universal design" to allow for multiple uses of the river (i.e. motorized, non-motorized, and angling) for all, especially for those with limited mobility, the elderly, and families with children. Concept designs with renderings and cost estimates were completed as a step in the water trail planning process in order to assist with fundraising and grant writing.

Contract Purpose: The purpose of this two year cooperative agreement is to work with MCCB to retain a consultant to provide engineering services for three river accesses (Bennett, Spring Park, and T-38) located on the Cedar River in Mitchell County, and construct a hard surface boat ramp at T-38 Access. Engineering services for this project include completed designs and construction documents, permitting, and bid letting for all three projects. Bidding, construction, and oversight of the boat ramp at T-38 will be managed by MCCB.

Budget:

DNR Contribution (65%):	Not to exceed \$120,000.00
MCCB Contribution (35%):	Not to exceed \$ 42,340.00
Total Cost:	Not to exceed \$162,340.00

Anticipated Future Work: Future work will include fundraising and construction of accesses and parking at Bennett and Spring Park, and parking only at T-38 (access construction at T-38 is included in this agreement).

The Natural Resource Commission is requested to approve a renewal of the management agreement with the Clayton County Sheriff's Department for the Emergency Radio Communications Tower located within Pikes Peak State Park.

Location: The area is 1.5 miles south of McGregor in Clayton County.

Site Purpose: This renewal allows the Clayton County Sheriff's Department to manage, care for, and maintain the emergency radio communications tower located within Pikes Peak State Park.

Management History: The original Management Agreement was approved in 1998.

Management Agreement Term: The term of this Agreement with the Clayton County Sheriff's Department is 25 years.

***12.2 Contract with Scott County Conservation Board, Land Management/Maintenance**

Commission approval is requested for a contract with Scott County Conservation Board.

Contract Terms

Amount: not to exceed \$30,000 per year

Dates: July 1, 2022 to June 30, 2027

Funding Source(s): Fish & Wildlife Trust 69%, Marine Fuel Tax 31%

Contract Purpose: Lost Grove Lake in Scott County, Iowa, contains public access areas with trails, jetties, fishing parallel structures, restroom facilities, boat ramps, and parking lots. Maintenance is required to keep the area safe and usable for the public. Scott County Conservation Board (Scott CCB) has multiple maintenance staff and the equipment available at nearby Scott County Park to maintain Lost Grove Lake and react to maintenance issues more quickly than DNR staff, who are not located in the area. Scott CCB is also able to maintain a regular presence at Lost Grove Lake which helps deter issues such as vandalism. Scott CCB has been conducting maintenance at Lost Grove Lake under annual agreements since 2016.

Tasks in this agreement include: mowing and trimming grassy areas and along structures; trimming weeds and woody debris from jetties and structures and applying aquatic-safe herbicide as needed; dragging trails, jetties, and structures after significant rainfall events; spreading limestone gravel; trash removal; clean and sanitize pit vault toilets; and snow removal.

Scott CCB's partnership, coordination, and cooperation have been an asset to the care of the lake area. Scott County Conservation Board officially and unanimously approve the above maintenance contract for Lost Grove Lake at their regular meeting on May 11, 2022.

Selection Process Summary: Intergovernmental contracting is authorized under 11 IAC 118.7.

13.1 Goshen Wildlife Management Area, Lucas County – Iowa Natural Heritage Foundation

The Natural Resource Commission's approval is requested to purchase a tract of land located in Lucas County adjacent Goshen Wildlife Management Area (WMA).

Seller: Iowa Natural Heritage Foundation

Acreage: 104 acres

DNR Purchase Price: \$312,000

Appraised Price: \$403,000

Property Description: This irregular-shaped property is located five miles south of Lucas in southwestern Lucas County. The steep to near level tract lies within an upslope from the Chariton River floodplain. Land use includes 20 acres of cropland in one, irregular-shaped field, 78 acres of grassland and timber, and 6 acres of road right of way. There are no building improvements. Highway 65 provides public access along the entire east boundary of the property. A county gravel road provides additional access along the entire south side of the tract.

Purpose: This acquisition will allow for public access to hunting and other outdoor recreation opportunities. The addition also improves access to the Goshen area located on the south side of the Chariton River.

15. Construction Projects

***15.1 Green Valley State Park, Boat Ramp Parking Expansion – Union County**

The Department requests Commission approval of the following construction project:

Project Summary: Opened in 1952, Green Valley State Park encompasses more than 1,100 acres, including a 390-acre lake. Existing facilities include a lakeshore campground with modern facilities, lakeshore camper cabins, fishing jetties, 10-mile trail, three boat ramps, and a beach.

The existing parking lot at Green Valley’s main boat ramp parking lot consists of both asphalt and concrete surfacing in the main lot and a grass overflow parking lot. This project will replace approximately 2,500 square yards of grass parking with 450 tons of crushed stone.

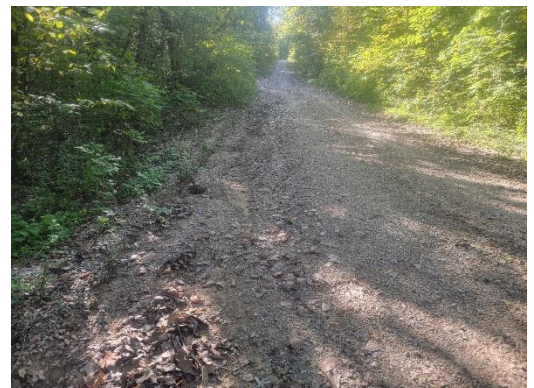

***15.2 Eldon WMA, Road Maintenance- Davis County**

The Department requests Commission approval of the following construction project:

Project Summary: The Eldon Wildlife Management Area is located approximately four miles east of Floris, Iowa. This 1,290-acre area is comprised of timber and upland habitat that supports deer, turkey, and squirrels.

This project consists of 0.4 miles of granular road way maintenance, consisting of reestablishing the roadway crown, cleaning out ditches, and spreading 570 tons of new rock. Additionally, two 18-inch diameter culverts will be replaced and two rock check dams will be constructed.

15.3 Maquoketa Caves State Park, Stair Fabrication and Installation - Jackson County

The Department requests Commission approval of the following construction project:

Project Summary: Maquoketa Caves State Park is located in Jackson County, northwest of Maquoketa, Iowa. The 370-acre park was opened to the public in the 1930’s when the CCC built a lodge and walkways through the cave system. In addition to the caves and the lodge, the park has hiking trails, a museum, two picnic shelters, and a modern campground.

The stair structures at Middle Dance Hall Cave and at Twin Arches Trail were constructed in the late 1980’s. The structures have sustained damage over the years due to fallen trees as well as typical wear and tear. Both structures need replacement. The contractor will demolish the existing stairs at both locations and install new stairs: pre-fabricated steel stairs will be installed at Middle Dance Hall Cave and, at Twin Arches Trail, C channel and angle steel stairs will be attached to the existing rebar foundation system and new 2x6 treated lumber will be installed over the steel treads as the walking surface.

15.4 Ingham-High Complex, Shoreline Armoring- Emmet County

The Department requests Commission approval of the following construction project:

Project Summary: The Ingham-High Complex Wildlife Area is located approximately five miles east of Wallingford. This 3,209-acre area is comprised of lake, marsh, timber, and upland habitat that supports deer, squirrel, pheasant, waterfowl, rabbit, and dove.

A 4,000-foot section of roadway runs right beside Ingham lake on the north and west side. The shoreline has been slowly eroding throughout years of wave action and is incurring detrimental erosion in several areas. After selective tree clearing and minor bank shaping, 3,630 tons of natural fieldstone will be placed along the shoreline on the western side of the lake.

This project consists of 0.8 miles of granular roadway maintenance, consisting of reestablishing the roadway crown, cleaning out ditches, and spreading 968 tons of new rock. Additionally, a 36” diameter culvert will be replaced.

***16. Contract with JEO Consulting Group, Inc.**

Commission approval is requested for a contract with Trees JEO Consulting Group, Inc. of Wahoo, NE.

Contract Terms

Amount: Not to exceed \$64,980

Dates: June 13, 2022 to May 31, 2023

Funding Source(s): Woodland Health Initiative

Contract Purpose: To assist 18 Iowa communities with planning and managing their urban tree resources, development of response to the presence of Emerald Ash Borer and other tree pests and problems. As a part of the project each eastern Iowa community included in the contract will receive an inventory of street and park trees, a visual survey of forest health symptoms, a summary of benefits those trees, and an urban forest management plan. Tasks include:

- Inventory street and park trees in identified communities. Collect data for each tree that includes all require categories for data collection, i.e., GPS derived locations for each tree and data elements for each tree.
- Visually survey all trees for signs and symptoms of invasive pest and disease in the identified communities, return data to DNR in shapefile format via e-mail.
- Calculate the benefit of the street and park trees using the most current version of i-Tree and create maps of the trees for each urban forest management plan.
- Finalize urban forest management plans for the identified communities and submit plans to DNR for approval.
- Presentation of the urban forest management plans to each community.

Communities include: Anamosa, Cumming, Early, Ely, Fenton, Harcourt, Monona, New Hampton, Preston, Primghar, Riverdale, Rolfe, Spillville, St. Ansgar, University Heights, Villisca, Wapello, and Winterset.

This process was done annually since 2012 for 173 other communities in total. These inventories and plans have aided communities with current information to make tree care and budget decisions. The data collected in these have help prioritize removal and treatment of ash trees as well as monitored for pests like walnut twig beetle that is necessary for Iowa to continue international sale of wood products.

Selection Process Summary: The Department solicited proposals from 198 in-state arborists and national tree inventory companies. Proposals were scored based on the criteria as described in the RFP which included cost of service and experience conducting street tree inventories and writing urban forestry management plans which includes work plan, past work projects, capacity of respondent and mechanism for GIS collection.
