**Contract Purpose:** This contract will utilize a contractor with the knowledge and equipment necessary to plant bare root nursery trees from the State Forest Nursery. This planting will enhance the Little Sioux Wildlife Management Area adding diversity in the tree species along the Little Sioux River in Clay county in northwest Iowa and, over time as the plantings mature, provide quality habitat to a variety of wildlife.

By using the tree planting plan developed by the DNR's district forester, the contractor will plant a 23 acre tree planting consisting of 4,325 Bur Oak trees, 4,175 Hackberry trees, 1,000 Black Cherry trees, and 1,000 Black Walnut trees. Contract tasks include:

- Tree planting site prep including planting layout and planting row preparation.
- Planting the provided trees with a mechanical tree planter with row spacing 10 feet apart with trees 8 feet apart within the rows.

• After planting is completed, supplying and installing 1,150 vented tree tubes which will be 50 trees per acre.

**Amendment Purpose:** This amendment will continue the services outlined in the original contract for brush and tree removal and piling services. The contractor was able to complete the initial work within the environmental timeframe of October 31<sup>st</sup> – March 31<sup>st</sup>, The contractor will be assigned additional areas in the following WMAs (Iowa River Corridor, Hawthorn, Kunch, Union Grove, East Salt Creek, Hawkeye, Red Bird, and Dudgeon Lake). This work is part of the wildlife management plan for prairie restoration.

**Original Contract Purpose:** This contract provides services for the removal of invasive small woody brush and trees to allow for the restoration of reconstructed and remnant prairie as well as remnant oak savanna. This work will be done in the following Wildlife Management Areas: Iowa River Corridor, Hawthorn, Kunch, Union Grove, Hawkeye, Red Bird, and Dudgeon Lake. Tasks include: invasive brush removal and grinding; invasive tree removal; and piling of trees service. To meet environmental requirements related to non-disturbance of bat habitat and the reduction of Oak wilt disease transmission, this work will be done between October 31<sup>st</sup> and March 31<sup>st</sup>. Local staff will work with the contractor to prioritize the locations and tasks.

**Original Selection Process:** The Department solicited proposals from targeted small businesses and also published a request of proposals (RFP) on the Department of Administrative Services website.

# 8. Contract with Iowa State University (MSIM)

Commission approval is requested for a contract with Iowa State University, of Ames, Iowa.

# **Contract Terms:**

Amount: Not to exceed \$990,171

Dates: January 1, 2023 to December 31, 2024

Funding Source(s): Federal USFWS State Wildlife Grant Program Funds

**Contract Purpose:** The Multiple Species Inventory and Monitoring Program (MSIM) was first developed under contract with ISU in 2004-2006. In 2006, a crew of 4 seasonal employees began collecting data on 8 taxonomic groups in 3 counties in southern Iowa. MSIM was housed fully within DNR from 2006 – 2011. Since 2012, ISU and DNR have partnered together on implementing MSIM using seasonal employees through ISU. To date, the following have been documented: 20 (of 22) species of amphibians, 41 (of 46) reptile species, 290 species of birds (of 310 breeding or regular migratory) as well as 23 of 95 bird vagrant species, 107 butterflies (of 123), 55 mammals (of 63), 26 mussels (of 52), 97 fish (of 155), and 110 species of dragonflies (of 118).

This two year contract with ISU will support a project managing biologist and up to 25 seasonal employees to collect data for the MISM Program, March-October of each year. ISU will follow Iowa DNR's MSIM protocols to collect data on up to 75 identified public and private areas in 2023 and 2024. Objectives include:

- Conduct MSIM surveys for birds, mammals, amphibians, reptiles, fish, mussels, butterflies, odonates, and crayfish, along with data on habitat conditions, on 50 Wildlife Management Areas annually during 2023-2024, with the potential for up to 25 additional properties as funding allows.
- Enter collected data into the MSIM on-line database, submit occurrence records, and update database records.
- Analyze data using, but not limited to, proportion of area occupied and species density using habitat variables from the field and/or GIS where applicable.

By following MSIM protocols, these data will meet criteria necessary for Iowa's statewide database which will contribute toward the assessment of the identified taxonomic groups. In addition, the MSIM protocols meet the Congressional requirement for monitoring species and habitats to continue receiving State Wildlife Grant funds, funds which are required to be spent on species of greatest conservation need. To meet the federally required match, ISU will be providing up to \$533,169 toward this project.

Contractor Selection Process: Intergovernmental contracting with ISU is authorized under 11 IAC 118.4.

# 9. Contract with Visual Labs, Inc. (spend authorization)

Commission approval is requested for the expenditure of funds under a contract with Visual Labs, Inc. of Menlo Park, California.

# **Contract Terms**

Amount: Not to exceed \$96,000 Dates: September 16, 2022, to September 15, 2026 Funding Source(s): General Fund

**Contract Purpose:** The original contract with Visual Labs is for body worn cameras for DNR law enforcement. It is a per device agreement that authorizes the addition or reduction of devices as needed. This allows for business flexibility, but does require the Commission to subsequently approve spend authorizations under the contract. The Commission previously approved a Parks Bureau spend authorization on 10/08/20.

Visual Labs, Inc. provides various services to DNR staff, including implementing and training DNR staff on equipment and software, storage of body camera footage on a proprietary smartphone application, access to the Microsoft Azure Government Cloud via the Visual Labs website. The fee structure of the contract included system implementation and training costs, media storage, and a monthly cost per activated device of \$48.50 per month.

#### November 10, 2022

This contract was extended for an additional two years on 09/07/22. The 09/07/22 decision item also reflected the cost to implement the body worn camera system for officers of the DNR Law Enforcement Bureau (via the Trust fund).

Parks is now asking for a spend authorization for body cameras for the Park Rangers (via the General Fund). Cell phone devices have been deployed to our current DNR State Parks Bureau officers and are used primarily as a body worn camera to record the audio and video of interactions between DNR staff and the general public. While the Visual Labs Application is engaged, each device will also record and, in certain cases transmit, the approximate physical location (i.e. latitude and longitude) of the device. Devices will be activated with a cellular carrier; the cost of this connectivity is the responsibility of the DNR.

Cost for the service includes: \$48.50 per month per device subscription fee. Each subscription will include a monthly allowance of up to 600 hours of video uploads, up to 600 hours of audio recordings uploaded, up to 5 hours of live streaming video, and up to 1,500 photos via the photo sequence function or the incident reporting function. Devices added during the month will have monthly allowances on a pro rata basis. All footage is owned by the DNR.

**Selection Process Summary:** The DNR followed the Department of Administrative Services procedures to obtain approval for sole source procurement, authorized under 11 IAC 118.

Iowa law requires most persons, whether a resident or a nonresident, to obtain an applicable license and pay a fee prior to fishing, hunting, or trapping.

**Proposed Rule Change:** 2022 Iowa Acts, Senate File 581 (signed into law on June 17, 2022), broadens the qualifications for who may obtain a lifetime trout fishing license to include Iowa residents who "... qualif[y] for the disabled veteran homestead credit under section 425.15." 2022 Iowa Acts, Senate File 2383 (signed into law on June 16, 2022), establishes a new annual armed forces fishing license and a new annual armed forces hunting and fishing combined license to be issued to any resident of Iowa who has served in the armed forces of the United States on federal active duty (collectively, "veteran licenses"). The law provides that the fee for the new veteran licenses shall be no more than five dollars.

The Natural Resource Commission (Commission) hereby proposes to amend Chapter 15, "General License Regulations," Iowa Administrative Code.

# Legal Authority for Rule Making

This rule making is proposed under the authority provided in Iowa Code sections 455A.5(6)"a" and 483A.1(1). State or Federal Law Implemented

This rule making implements, in whole or in part, 2022 Iowa Acts, Senate File 581 and Senate File 2383.

Purpose and Summary

Chapter 15 establishes hunting, fishing, and trapping license fees and governs license sales and refunds, among other topics. Iowa law requires most persons, whether residents or nonresidents, to obtain an applicable license and pay a fee prior to fishing, hunting, or trapping.

2022 lowa Acts, Senate File 581 (signed into law on June 17, 2022), broadens the qualifications for who may obtain a lifetime trout fishing license to include lowa residents who "... qualif[y] for the disabled veteran homestead credit under section 425.15." 2022 lowa Acts, Senate File 2383 (signed into law on June 16, 2022), establishes a new annual armed forces fishing license and a new annual armed forces hunting and fishing combined license to be issued to any resident of lowa who has served in the armed forces of the United States on federal active duty (collectively, "veteran licenses"). # 11. Chapter 30 - Waters Cost-Share and Grant Programs, Water Recreation Access Cost-Share (WRAC) Grants (FY 2023)

The Commission is requested to approve funding for the recommended Water Recreation Access Cost-Share (WRAC) Grant applications pursuant to Iowa Administrative Code Chapters 571-30.

**Grant Purpose**: The Water Recreation Access Grants are awarded annually to assist governmental entities in providing or improving water access for recreation purposes. **Contract Purpose:** This contract will initiate mitigation for recreational safety and fish passage for the Lower and Upper Dams on the Upper Iowa River, which are downstream of Decorah within 4 miles of each other. Both dams are located in wildlife units, and both are in a state of disrepair. In addition, both dams create recreational hazards and barriers for fish and mussel migration. Two conceptual alternatives will be investigated at each dam for local public and stakeholder opinion, technical and permitting constraints, river navigation, impacts on river health and aquatic life, impacts to surrounding infrastructure, sediment impacts, flood reduction scenarios, cost, and archaeological/historical considerations.

At each dam, a removal scenario will be considered along with a rapids scenario at a lower elevation than the existing dam. At the Lower Dam site, there is an opportunity to add approximately a mile of recreational river experience along limestone bluffs while stabilization longstanding erosion issues. Using this information, renderings of potential project types will be shared with stakeholders for input. A decision matrix demonstration for DNR wildlife, fisheries, and river programs staff and supervisors to use in making long range decisions for the river and the surrounding wildlife areas. The decisions for each structure will be used along with deliverables to inform a scope of work for future engineering design projects and permitting for each dam. Tasks for this contract include:

- Review existing data such as existing infrastructure along river, mapping, gage, and flood models.
- Physical survey of river and banks in impounded areas above both dams to a half mile downstream.
- Early permitting reviews with state and federal regulators.
- Develop flood model to analyze alternatives.
- Hold public meetings and partner / stakeholder meetings.
- Sediment review and geomorphic report to evaluate impacts of removal and measures need to avoid negative effects.
- Initial mussel reconnaissance survey and report.
- Provide two conceptions designs with renderings and cost estimates for each dam area.
- Identify areas of potential effect developed for National Historic Preservation Act evaluation.
- Phase 1 Archaeological / Architectural History field work, evaluation and report.
- Complete analysis report laying out constraints and opportunities and a matrix easily understandable for the public to facilitate decision making process.

**Contract Purpose:** The salamander mussel (*Simpsonaias ambigua*) is imperiled throughout its range and is currently under review by U. S. Fish and Wildlife Service (FWS) for protection under the Endangered Species Act (ESA). The salamander mussel is a small, thin-shelled mussel found in medium to large sized rivers. While most all North American mussels require a fish host to complete the reproductive cycle, the salamander mussel is the only one known to utilize the mudpuppy (*Necturus maculosus*). Salamander mussel larvae (called glochidia) attach to mudpuppy gills for a period time before falling off as a juvenile mussel into the stream. The salamander mussel is habitat specific using the riverine habitat similar to those used by the mudpuppy (e.g., under flat rocks).

The distribution and range of the salamander mussel and its glochidial host, the mudpuppy, are largely unknown in lowa. Our current understanding of the salamander mussel, based on incidental observations, is limited to the Mississippi River and a single historical account on its abundance in the Iowa River in Iowa City. While several statewide mussel surveys have been completed on interior rivers in Iowa, the salamander mussel may have gone undetected in previous efforts due to its small size and restrictive habitat use. For the mudpuppy, information on the distribution and range in the state is largely limited to incidental (angler) observations.

Targeted surveys focused on the best available suitable habitat for both species will improve our understanding of range and distribution and provide baseline information essential to conservation planning in the future. This 3-year study includes surveys for both the salamander mussel and the mudpuppy on interior rivers reaches in northeast lowa. Major tasks associated with this contract include:

- 1. Conduct visual and tactile searches for the salamander mussel and capture surveys for mudpuppy.
- 2. Perform an evaluation of key habitat characteristics at all sites surveyed
- 3. Summarize information gathered and provide the DNR with a report on the distribution and range of salamander mussel and mudpuppy found in this study.

## 18.6 Rock Creek State Park, Sanitary Sewer Liner – Jasper County

The Department requests Commission approval of the following construction project:

**Project Summary:** Located about 6 miles northwest of Kellogg, Rock Creek State Park is approximately 1,697 acres in size, and was dedicated in 1952. The 175-site campground borders the lake and includes electrical hookups and modern restrooms. **Contract Purpose:** This contract will utilize a contractor with the knowledge and equipment necessary to plant bare root nursery trees from the State Forest Nursery. This planting will enhance the Little Sioux Wildlife Management Area adding diversity in the tree species along the Little Sioux River in Clay county in northwest Iowa and, over time as the plantings mature, provide quality habitat to a variety of wildlife.

By using the tree planting plan developed by the DNR's district forester, the contractor will plant a 23 acre tree planting consisting of 4,325 Bur Oak trees, 4,175 Hackberry trees, 1,000 Black Cherry trees, and 1,000 Black Walnut trees. Contract tasks include:

This work is part of the wildlife management plan for prairie restoration.

**Original Contract Purpose:** This contract provides services for the removal of invasive small woody brush and trees to allow for the restoration of reconstructed and remnant prairie as well as remnant oak savanna. This work will be done in the following Wildlife Management Areas: Iowa River Corridor, Hawthorn, Kunch, Union Grove, Hawkeye, Red Bird, and Dudgeon Lake. Tasks include: invasive brush removal and grinding; invasive tree removal; and piling of trees service. To meet environmental requirements related to non-disturbance of bat habitat and the reduction of Oak wilt disease transmission, this work will be done between October 31<sup>st</sup> and March 31<sup>st</sup>. Local staff will work with the contractor to prioritize the locations and tasks.

# 8. Contract with Iowa State University (MSIM)

Commission approval is requested for a contract with Iowa State University, of Ames, Iowa.

# **Contract Terms:**

Amount: Not to exceed \$990,171 Dates: January 1, 2023 to December 31, 2024 Funding Source(s): Federal USFWS State Wildlife Grant Program Funds

**Contract Purpose:** The Multiple Species Inventory and Monitoring Program (MSIM) was first developed under contract with ISU in 2004-2006. In 2006, a crew of 4 seasonal employees began collecting data on 8 taxonomic groups in 3 counties in southern Iowa. MSIM was housed fully within DNR from 2006 – 2011. Since 2012, ISU and DNR have partnered together on implementing MSIM using seasonal employees through ISU. To date, the following have been documented: 20 (of 22) species of amphibians, 41 (of 46) reptile species, 290 species of birds (of 310 breeding or regular migratory) as well as 23 of 95 bird vagrant species, 107 butterflies (of 123), 55 mammals (of 63), 26 mussels (of 52), 97 fish (of 155), and 110 species of dragonflies (of 118).

This two year contract with ISU will support a project managing biologist and up to 25 seasonal employees to collect data for the MISM Program, March-October of each year. ISU will follow Iowa DNR's MSIM protocols to collect data on up to 75 identified public and private areas in 2023 and 2024. Objectives include:

- Conduct MSIM surveys for birds, mammals, amphibians, reptiles, fish, mussels, butterflies, odonates, and crayfish, along with data on habitat conditions, on 50 Wildlife Management Areas annually during 2023-2024, with the potential for up to 25 additional properties as funding allows.
- Enter collected data into the MSIM on-line database, submit occurrence records, and update database records.
- Analyze data using, but not limited to, proportion of area occupied and species density using habitat variables from the field and/or GIS where applicable.



By following MSIM protocols, these data will meet criteria necessary for Iowa's statewide database which will contribute toward the assessment of the identified taxonomic groups. In addition, the MSIM protocols meet the Congressional requirement for monitoring species and habitats to continue receiving State Wildlife Grant funds, funds which are required to be spent on species of greatest conservation need. To meet the federally required match, ISU will be providing up to \$533,169 toward this project.

# 9. Contract with Visual Labs, Inc. (spend authorization)

Commission approval is requested for the expenditure of funds under a contract with Visual Labs, Inc. of Menlo Park, California.

# **Contract Terms**

Amount: Not to exceed \$96,000 Dates: September 16, 2022, to September 15, 2026 Funding Source(s): General Fund

**Contract Purpose:** The original contract with Visual Labs is for body worn cameras for DNR law enforcement. It is a per device agreement that authorizes the addition or reduction of devices as needed. This allows for business flexibility, but does require the Commission to subsequently approve spend authorizations under the contract. The Commission previously approved a Parks Bureau spend authorization on 10/08/20.

Visual Labs, Inc. provides various services to DNR staff, including implementing and training DNR staff on equipment and software, storage of body camera footage on a proprietary smartphone application, access to the Microsoft Azure Government Cloud via the Visual Labs website. The fee structure of the contract included system implementation and training costs, media storage, and a monthly cost per activated device of \$48.50 per month. This contract was extended for an additional two years on 09/07/22. The 09/07/22 decision item also reflected the cost to implement the body worn camera system for officers of the DNR Law Enforcement Bureau (via the Trust fund).

Parks is now asking for a spend authorization for body cameras for the Park Rangers (via the General Fund). Cell phone devices have been deployed to our current DNR State Parks Bureau officers and are used primarily as a body worn camera to record the audio and video of interactions between DNR staff and the general public. While the Visual Labs Application is engaged, each device will also record and, in certain cases transmit, the approximate physical location (i.e. latitude and longitude) of the device. Devices will be activated with a cellular carrier; the cost of this connectivity is the responsibility of the DNR.

Cost for the service includes: \$48.50 per month per device subscription fee. Each subscription will include a monthly allowance of up to 600 hours of video uploads, up to 600 hours of audio recordings uploaded, up to 5 hours of live streaming video, and up to 1,500 photos via the photo sequence function or the incident reporting function. Devices added during the month will have monthly allowances on a pro rata basis. All footage is owned by the DNR.

**Selection Process Summary:** The DNR followed the Department of Administrative Services procedures to obtain approval for sole source procurement, authorized under 11 IAC 118.

The Commission is requested to approve Chapter 15, "General License Regulations," Notice of Intended Action.

**Basic Intent of Current Rule:** Chapter 15 establishes hunting, fishing, and trapping license fees, and also governs license sales and refunds, among other topics. Iowa law requires most persons, whether a resident or a nonresident, to obtain an applicable license and pay a fee prior to fishing, hunting, or trapping.

**Proposed Rule Change:** 2022 Iowa Acts, Senate File 581 (signed into law on June 17, 2022), broadens the qualifications for who may obtain a lifetime trout fishing license to include Iowa residents who "... qualif[y] for the disabled veteran homestead credit under section 425.15." 2022 Iowa Acts, Senate File 2383 (signed into law on June 16, 2022), establishes a new annual armed forces fishing license and a new annual armed forces hunting and fishing combined license to be issued to any resident of Iowa who has served in the armed forces of the United States on federal active duty (collectively, "veteran licenses"). The law provides that the fee for the new veteran licenses shall be no more than five dollars.

Iowa Code section 483A.1 requires that all license fees be promulgated in rule. Accordingly, this proposed rule making adds these new licenses to Chapter 15 and establishes a \$5 fee for each of the new veteran licenses. The lifetime trout fishing fee of \$63 already exists in Chapter 15.

# Proposing rule making related to lifetime trout fishing license for disabled veterans, annual fishing and hunting licenses for veterans, and providing an opportunity for public comment

The Natural Resource Commission (Commission) hereby proposes to amend Chapter 15, "General License Regulations," Iowa Administrative Code.

# Legal Authority for Rule Making

This rule making is proposed under the authority provided in Iowa Code sections 455A.5(6)"a" and 483A.1(1). *State or Federal Law Implemented* 

This rule making implements, in whole or in part, 2022 Iowa Acts, Senate File 581 and Senate File 2383.

Purpose and Summary

Chapter 15 establishes hunting, fishing, and trapping license fees and governs license sales and refunds, among other topics. Iowa law requires most persons, whether residents or nonresidents, to obtain an applicable license and pay a fee prior to fishing, hunting, or trapping.

Iowa Code section 483A.1 requires that all license fees be promulgated in rule. Accordingly, this proposed rule making adds these new licenses to Chapter 15 and establishes a \$5 fee for each of the new veteran licenses. The lifetime trout fishing fee of \$63 already exists in Chapter 15.

# 11. Chapter 30 - Waters Cost-Share and Grant Programs, Water Recreation Access Cost-Share (WRAC) Grants (FY 2023)

The Commission is requested to approve funding for the recommended Water Recreation Access Cost-Share (WRAC) Grant applications pursuant to Iowa Administrative Code Chapters 571-30.

**Grant Purpose**: The Water Recreation Access Grants are awarded annually to assist governmental entities in providing or improving water access for recreation purposes. State cost-share funding is provided at 75% with the local 25% contribution coming from in-kind or monetary match if the project is not under a management agreement with the State of Iowa. #### **Contract Terms**

**Contract Purpose:** This contract will initiate mitigation for recreational safety and fish passage for the Lower and Upper Dams on the Upper Iowa River, which are downstream of Decorah within 4 miles of each other. Both dams are located in wildlife units, and both are in a state of disrepair. In addition, both dams create recreational hazards and barriers for fish and mussel migration. Two conceptual alternatives will be investigated at each dam for local public and stakeholder opinion, technical and permitting constraints, river navigation, impacts on river health and aquatic life, impacts to surrounding infrastructure, sediment impacts, flood reduction scenarios, cost, and archaeological/historical considerations.

At each dam, a removal scenario will be considered along with a rapids scenario at a lower elevation than the existing dam. At the Lower Dam site, there is an opportunity to add approximately a mile of recreational river experience along limestone bluffs while stabilization longstanding erosion issues. Using this information, renderings of potential project types will be shared with stakeholders for input. A decision matrix demonstration for DNR wildlife, fisheries, and river programs staff and supervisors to use in making long range decisions for the river and the surrounding wildlife areas. The decisions for each structure will be used along with deliverables to inform a scope of work for future engineering design projects and permitting for each dam. Tasks for this contract include:

- Review existing data such as existing infrastructure along river, mapping, gage, and flood models.
- Physical survey of river and banks in impounded areas above both dams to a half mile downstream.
- Early permitting reviews with state and federal regulators.
- Develop flood model to analyze alternatives.
- Hold public meetings and partner / stakeholder meetings.
- Sediment review and geomorphic report to evaluate impacts of removal and measures need to avoid negative effects.
- Initial mussel reconnaissance survey and report.
- Provide two conceptions designs with renderings and cost estimates for each dam area.
- Identify areas of potential effect developed for National Historic Preservation Act evaluation.
- Phase 1 Archaeological / Architectural History field work, evaluation and report.
- Complete analysis report laying out constraints and opportunities and a matrix easily understandable for the public to facilitate decision making process.

**Contract Purpose:** The salamander mussel (*Simpsonaias ambigua*) is imperiled throughout its range and is currently under review by U. S. Fish and Wildlife Service (FWS) for protection under the Endangered Species Act (ESA). The salamander mussel is a small, thin-shelled mussel found in medium to large sized rivers. While most all North American mussels require a fish host to complete the reproductive cycle, the salamander mussel is the only one known to utilize the mudpuppy (*Necturus maculosus*). Salamander mussel larvae (called glochidia) attach to mudpuppy gills for a period time before falling off as a juvenile mussel into the stream. The salamander mussel is habitat specific using the riverine habitat similar to those used by the mudpuppy (e.g., under flat rocks).

The distribution and range of the salamander mussel and its glochidial host, the mudpuppy, are largely unknown in lowa. Our current understanding of the salamander mussel, based on incidental observations, is limited to the Mississippi River and a single historical account on its abundance in the Iowa River in Iowa City. While several statewide mussel surveys have been completed on interior rivers in Iowa, the salamander mussel may have gone undetected in previous efforts due to its small size and restrictive habitat use. For the mudpuppy, information on the distribution and range in the state is largely limited to incidental (angler) observations.

Targeted surveys focused on the best available suitable habitat for both species will improve our understanding of range and distribution and provide baseline information essential to conservation planning in the future. This 3-year study includes surveys for both the salamander mussel and the mudpuppy on interior rivers reaches in northeast lowa. Major tasks associated with this contract include:

- 1. Conduct visual and tactile searches for the salamander mussel and capture surveys for mudpuppy.
- 2. Perform an evaluation of key habitat characteristics at all sites surveyed
- 3. Summarize information gathered and provide the DNR with a report on the distribution and range of salamander mussel and mudpuppy found in this study.

**Selection Process Summary:** The Department solicited proposals and also published a Request for Proposal on the Department of Administrative Services website. Criteria reviewed included the service provider's capacity to complete the work within the timeframe requested, past performance of work identical or similar to the project, demonstration of expertise, and cost. **18.5** Rock Creek State Park, Sanitary Sewer Liner – Jasper County The Department requests Commission approval of the following construction project:

**Project Summary:** Located about 6 miles northwest of Kellogg, Rock Creek State Park is approximately 1,697 acres in size, and was dedicated in 1952. The 175-site campground borders the lake and includes electrical hookups and modern restrooms. The park offers trails to accommodate a wide variety of activities, including hiking, horseback riding, cross country skiing, and snowmobiling.

The Rock Creek State Park sewer collection system consists of 2,549 feet of 6-inch diameter clay tile pipes. The clay tile pipes, over time, have deteriorated and have collapsed at various points. The gravity sewer system also has a substantial problem with infiltration at the joints and has tree roots coming through. This project will replace pipe at collapsed/broken areas, remove roots that have penetrated the pipe, and will install a cured-in-place pipe liner.
