The Natural Resource Commission (Commission) hereby proposes to amend Chapter 106, "Deer Hunting by Residents", Iowa Administrative Code.

#### Legal Authority for Rule Making

This rule making is proposed under the authority provided in Iowa Code sections 455A.5(6)"a", 481A.39 and 481A.48.

#### State or Federal Law Implemented

This rule making implements, in whole or in part, Iowa Code Sections 481A.38, 481A.39 and 481A.48.

#### Purpose and Summary

Chapter 106 governs deer hunting by residents in the state of Iowa. This chapter regulates deer hunting and sets forth season dates, bag limits, possession limits, shooting hours, areas open to hunting, licensing procedures, means and methods of take, and transportation and reporting requirements.

This rulemaking proposes three amendments to Chapter 106. First, two counties are added and two counties are removed from the list of counties available for general deer licenses.

Second, Lucas county is added to the list of counties eligible to participate in the Population Management January antlerless-deer-only season.

Third, antlerless-deer-only county quotas are modified to increase harvest in southern lowa where the wild herd is above population goals, and also in northcentral lowa, where wild herds have recovered to a level that can sustain additional antlerless harvest. Conversely, quotas are modified in far western lowa to decrease harvest where populations are below goals and hunter effort is waning.

General deer licenses shall be valid for taking deer of either sex except in Buena Vista, Calhoun, Cherokee, Clay, <u>Crawford, Dickinson, Emmet, Humboldt, Ida, Kossuth, Lyon, O'Brien, Osceola, Palo Alto, Plymouth, Pocahontas, Sac, and Sioux, and Woodbury Counties during the first regular gun season when the general deer license will be valid for taking deer with at least one forked antler. Paid general deer licenses shall be valid statewide except where prohibited in deer population management zones established under 571—Chapter 105. Free general deer licenses shall be valid for taking deer of either sex only on the farm unit of an eligible landowner or tenant in the season or seasons selected at the time the license is obtained.</u>

ITEM 2. Amend rule 571—106.1(6) as follows:

106.1(6) January antlerless-deer-only licenses.

*a. Population management season.* Licenses for the population management January antlerless-deer-only season may be issued for the following counties: Allamakee, Appanoose, Decatur, <u>Lucas</u>, Monroe, Wayne, and Winneshiek. Population management January antlerless-deer-only licenses shall be issued for a county only when a minimum of 100 antlerless-deer-only licenses, as described in subrule 106.6(6), remain unsold in that county as of the third Monday in December. If 100 or more antlerless-deer-only licenses remain unsold for a given county as of the third Monday in December, those remaining antlerless-deer-only licenses shall be made available for the population management January antlerless-deer-only licenses shall be made available for the population management January antlerless-deer-only season in that county until the relevant antlerless-deer-only quota as described in subrule 106.6(6) is met.

ITEM 3. Amend rule 571—106.6(6) as follows:

106.6(6) Antlerless-deer-only licenses. Paid antlerless-deer-only licenses will be available by county as follows:

**14.1 Ledges and Pine Lake State Park – Sign Installation – Boone and Hardin County** The Department requests Commission approval of the following construction project:

**Project Summary:** Ledges State Park is located just south of Boone, and was dedicated in 1924. Amenities within the park include a campground, numerous picnic areas, trails, and fishing and canoeing opportunities. It is also part of the 91-mile Central State Park Bike Route.

Pine Lake State Park is located immediately northeast of Eldora, and was dedicated in 1926. Amenities within the park include a campground, day use lodge, numerous shelters, a beach, hiking and cycling trails, and boat access to Upper Pine Lake, Lower Pine Lake, and the Iowa River.

This project will install wayfinding signage at both parks, including campground signage. ## 15. Contract with The Office of the State Archeologist at the University of Iowa

**Commission approval is requested for a contract with** The Office of the State Archeologist (OSA) at the University of Iowa, of Iowa City, Iowa.

#### **Contract Terms:**

**Amount:** Not to exceed \$700,000.00

Dates: March 9, 2023, to June 30, 2027

**Funding Source(s):** Funding sources will be project related; potential sources include, but are not limited to: Lake Restoration, USFWS Wildlife and Sport Fish Restoration Program, USFWS North American Wetland Conservation Act, State Duck Stamp, REAP Land Management and Open Spaces, and Marine Fuel Tax.

**Contract Purpose:** Archeological and architectural investigations are required for many construction and improvement projects completed on public land, including lake restoration projects, wildlife and fisheries capital projects, and parks improvement/capital projects. For the majority of projects associated with this Contract, a phase 1 survey will be completed by OSA for each work order. A phase 1 is an archeological survey that determines the presence or absence of archeological resources within a project area. Additional surveys may need to be completed if cultural resources are located within the project area.

The purpose of this 5-year contract is to allow DNR staff across CRD ready access to contract with OSA to complete archeological and architectural investigations by issuing work orders for individual projects under this master agreement. Issuing work orders for archeological and architectural work will improve efficiency by reducing staff time drafting and preparing contracts for each individual project. The previous 2-year contract with OSA was very successful in serving the needs of the DNR project officers, allowing for timely, efficient, and economical investigations of cultural and historical resource concerns at all project construction sites.

**Selection Process Summary:** Intergovernmental contracting with the University of Iowa is authorized under 11 IAC 118.4. Also contracts with state universities and other public agencies for laboratory work, scientific field measurement and environmental quality evaluation services are necessary to implement Iowa Code Chapter 455B is authorized under Iowa Code section 455B.103(3).

## 16. Contract with Windstream

## Commission approval is requested for a contract with Windstream.

## **Contract Terms:**

Amount: Not to exceed \$35,700.00Dates: March 9, 2023, to June 30, 2028Funding Source(s): Funding source for this project will the Fish and Wildlife Trust Fund.

**Contract Purpose:** The purpose of this contract is to bury fiber optic lines and provide 100 Mbps internet service to the Fish and Wildlife Station office in Red Haw State Park by June 30, 2023, and to provide 100 Mbps internet service to that location for five years from July 1, 2023, through June 30, 2028.

Current internet service to this station is extremely slow (<3 Mbps download and 0.5 Mbps upload) and there is not enough bandwidth to support the needs of the Fisheries and Wildlife field staff at that station. Additionally, current service is provided via an aging copper line that is sensitive to rain. Service frequently goes out completely during and after storm events. There is currently a fiber optic line at the highway but lines need to be buried from the road through the park to the station.

The Contractor's engineers will complete a site survey and determine the best path to bring the fiber into the building. The Contractor will provide a proposed plan for review and approval by the DNR. Upon receiving written approval from DNR, the Contractor will obtain necessary permits before commencing work. The Contractor will then provide service to this station for a period of five years. After that period (i.e., after the Contractor recoups their expenses to bury the line), service will continue at a reduced monthly rate.

## 17. Administrative Law Judge Proposed Decision Review (DIA No. 23DNRL0003) – In the Matter of Stuart Hagen

This matter comes before the Natural Resource Commission ("Commission") for review of a Proposed Decision issued by an Administrative Law Judge (ALJ) of the Iowa Department of Inspections and Appeals (DIA) in DIA case number 23DNRL0003 -- In the Matter of Stuart Hagen. The ALJ found that Mr. Hagen was convicted of the offenses alleged and that the DNR correctly calculated the points assigned to those convictions, requiring a three-year license suspension under Iowa Administrative Code 571-15.16(4). Mr. Hagen filed a timely appeal of the ALJ's Proposed Decision on December 6, 2022. The matter is now before the Commission for final agency action.

Mr. Hagen was convicted in Appanoose County District Court of seven violations of Iowa hunting, fishing, or trapping laws on July 27, 2021. This included two convictions of Iowa Code section 483A.26 (Making a False Claim to Obtain a License – Non-Resident), two convictions of Iowa Code section 483A.24 (Special License Violation), two convictions of Iowa Code section 483A.14 (Special License Violation), two convictions of Iowa Code section 483A.24 (Special License Violation), two convictions of Iowa Code section 483A.1(2)(i) (No Valid Non-Resident Deer License). *See* DNR Exhibits A-G. The Appanoose County District Court denied Mr. Hagen's appeal of the convictions on March 29, 2022.

These convictions carry a total of twenty-one points under the multiple offender points system established at IAC 571--15.16. The administrative rules provide that the accumulation of thirteen or more multiple offender points within a three-year period requires a three-year license suspension. The DNR notified Mr. Hagen of its intent to suspend and revoke his hunting, fishing, and furharvester privileges on July 11, 2022. Mr. Hagen filed a timely request for a hearing on the matter. The hearing with an ALJ took place on October 27, 2022.

On November 7, 2022, the ALJ issued a Proposed Decision affirming the Department's action. The ALJ found that the Department scored Mr. Hagen's convictions correctly and that the three-year suspension was required under the multiple offender rules.

Mr. Hagen is now appealing the ALJ's Proposed Decision to the Commission arguing he should not have been convicted of the above-named offenses. Arguments regarding the facts resulting in Mr. Hagen's convictions are improper at the administrative licensing stage, nor does the Commission have the authority to vacate convictions. *See Rilea v. State*, 959 N.W.2d 392, 395 (Iowa 2021).

The Department requests that the Commission affirm the ALJ's Proposed Decision. The Department has delayed the action against Mr. Hagen's licenses during the pendency of this appeal.

The Commission is being presented with the ALJ's Proposed Decision and the electronic record from the ALJ hearing. The Commission may reverse, in whole or in part, or uphold the ALJ's proposed decision by vote or no action, which constitutes final agency action.

The parties may be allowed oral arguments pursuant to rule 561 I.A.C. 7.17(5)(e). Mr. Hagen submitted a request for oral argument and continuance on January 17, 2023. The Natural Resource Commission voted to grant the continuance and request for oral argument on January 18, 2023. In addition, the Natural Resource Commission notified Mr. Hagen that any written materials, including any briefs of additional evidence, had to be submitted to the NRC by February 8, 2023. A brief was submitted by email on February 8, 2023.
