Contract Terms

Amount: Not to exceed \$33,750.00 **Dates**: 1/10/2024 to 6/1/2024

Funding Source(s): State Wildlife Grant - Blanding's Turtle Conservation in Iowa and Illinois

Contract Purpose: This six-month contract with Buffalo Creek Land Management, LLC will allow for the completion of the land management activities described in the Wildlife Management Plan.

Property Description: Charles and Kent Scheib own a 90-acre and 12-acre property, respectively, in Guthrie County, Iowa. The properties are under State Wildlife Grant - Blanding's Turtle Conservation in Iowa and Illinois agreements and will be allowing for the development of Blanding's Turtle habitat and will maintain the improvements until 12/1/2033.

Land Management Tasks: The Wildlife Management Plan outlines the land management tasks, which include tree removal and brush management. The DNR will assist the contractor with land management planning, provide technical assistance, and evaluate the completion of the land management tasks.

Selection Process Summary: The authority to enter into this Contract is 483A.3B(3)b. The RFB process was conducted with DNR procurement.

7. Contract with MSA Professional Services, Inc. (Lake Keomah Spillway Investigation)

Commission approval is requested for a contract with MSA Professional Services, Inc., of St. Paul, MN.

Contract Terms:

Amount: Not to exceed \$27,300.00

Dates: January 10, 2024 to October 30, 2025 **Funding Source(s):** Lake Restoration Program

Contract Background: The Lake Keomah dam is an 1100 foot long and 42 foot high earth embankment dam with a 60 foot wide reinforced concrete chute spillway. The Iowa DNR owns and operates the Lake Keomah dam facility, which has a water surface area of approximately 78 acres and volume of 725 acre-ft.

The Lake Keomah dam was built in the 1930s by CCC. The dam was originally designed by the National Park Service for the DNR. In 1965/66 the entire spillway was rebuilt. In 1992 more repairs to the spillway were performed. At this time a new drainage system under the chute spillway was installed. The replacement of 240 feet of the east wall and 210 feet of the west wall were also completed in 1992.

The DNR is concerned that the walls of the spillway were tipping inward and show some movement. In addition, there is deteriorated concrete in the floor and base of walls, stress cracks, and separated joints.

Contract Purpose: The DNR is entering into this Contract with MSA Professional Services, Inc., an engineering consulting company, to conduct in-depth condition assessment of the spillway and come up with a report that identifies probable causes of spillway failures and recommendations for rehabilitation. The engineering firm will also be responsible for developing design plans and specifications based on the findings for the spillway rehabilitation.

Selection Process Summary: The department solicited proposals from targeted small businesses and published a Request for Proposals (RFP) on the Department of Administrative Services website.

Proposal Due Date: 12/4/2023

Scoring Criteria: Proposals were scored based on the criteria as described in the RFP, which included their ability to complete the scope of work within the desired timeline, comprehensive work plan, description and quality of previous and applicable work experience, and cost.

8.1 Wildcat Den State Park, Pavement Maintenance - Muscatine County

The Department requests Commission approval of the following construction project:

Project Summary: Wildcat Den State Park is located near the Mississippi River between Davenport and Muscatine, and was dedicated in 1935. Park amenities include an historical nineteenth century grist mill, an historic oneroom schoolhouse, a 28-site primitive campground, two picnic shelters, various picnic areas, and diverse hiking trails.

This project consists of performing asphalt pavement maintenance on all roads within the park (approx. 1.6 miles). Maintenance activities include crack and joint repairs, minor pavement patching, fog sealing, replacing lost shoulder rock, cleaning out culverts, and reshaping ditches.

8.2 Okoboji View Wetland Complex, Wetland Reconstruction – Dickinson County

The Department requests Commission approval of the following construction project:

Project Summary: The Linda K. Phelps Revocable Trust Tract is a 78-acre Waterfowl Protection Area located within the Okoboji View Wetland Complex. The protection and restoration of this property continues efforts which began in 2009. The project is a partnership between the DNR, Iowa Heritage Foundation (INHF), Dickinson County Soil and Water Conservation District, Okoboji View Golf Course, U.S. Fish and Wildlife Service, U.S. EPA – Section 319 and private landowners.

This project is designed to restore/enhance two separate wetland pools on the Phelps tract and IDNR permanent

easement on the adjacent golf course. The first and larger basin will be restored by building a 6,500 ft long berm with a water control structure and emergency spillway. The second will be enhanced by breaking existing tile and performing a shallow water excavation to remove deposited sediment and deepen the basin for bio diversity. 
