IOWA CITY DEER MANAGEMENT PLAN-2024-2029

Geoff Fruin, City Manager for Iowa City, requested Commission approval of the 2024-2029 Iowa City deer management plan. Commissioners held a robust discussion on the inclusion of sharp shooting in the 5-year plan; specifically the Commission discussed whether sharp shooting was appropriate at all and, if so, when. The Commission decided that a report detailing the outreach done by the City to grow their bow management hunt would be required at the April 2026 NRC meeting, and that no sharp shooting was permissible until after it had reviewed that report. Mr. Prickett made a motion to amend the item stating that the City cannot hold a sharp shoot prior to September of 2026, and only if approved by the NRC Commission in April of 2026 after reviewing said report, and that language allowing a second sharp shoot without Commission approval be removed from the management plan.

6. Subrecipient Grant Agreement with the City of Dubuque

Commission approval is requested for an agreement with the City of Dubuque.

Contract Terms

Amount: Not to exceed \$170,100

Dates: July 1, 2024 to December 31, 2025

Funding Source(s): USFWS, Boating Infrastructure Grant Tier 1 Funds

Agreement Purpose: The USFWS Boating Infrastructure Grant (BIG) provides annual pass-through funding to States for docking and safe harbor for transient boaters and vessels. This grant program was created under the Sportfishing and Boating Safety Act of 1998 to provide funding for the construction, renovation and maintenance of boating infrastructure facilities for transient recreational vessels at least 26 feet long that are operated, leased, rented, or chartered primarily for pleasure. BIG receives its funding from two percent of the annual appropriation from the Sport Fish Restoration and Boating Trust Fund. The Act requires at least a 25 percent match from the applicant.

The DNR serves as the State agent and pass-through funds administrator for this program. Interested applicants complete the federal form and submit it to the State agent for processing. The State agent reviews and submits the qualified application on behalf of the applicant for federal review and approval. The successful applicant(s), then, enters into an agreement with the State agency outlining federal requirements.

Funds granted will be used by the City of Dubuque for dredging areas near and around the existing transient dock and continuing southeast toward the existing transient/fuel/water/pump-out dock. This will provide boaters safe access to the amenities of the Dubuque Marina and the City of Dubuque. It will also provide safe harbor for daily and overnight docking. Bathroom and shower facilities are currently available to these transient boaters.

Recommendation: One application was received for this grant cycle. The USFWS has approved the BIG grant award to the City of Dubuque. The review committee (State agent/DNR, USFWS, DNR Federal Aid Coordinator) recommends entering into this agreement with the grant awardee, City of Dubuque.

Soil fumigation is a management technique that is widely used in the nursery industry to eliminate soil pathogens and weed infestations prior to planting nursery crops.

Original Contract Purpose: The purpose of this contract is for the contractor to provide soil fumigation services to the lowa DNR State Forest Nursery to aid in growing quality tree seedlings. The contractor will perform soil fumigation using methyl bromide and chloropicrin products according to Federal and State Law. The rate to be applied is 325lb/acre at an injection depth of 10 inches using 67% methyl bromide and 33% chloropicrin. Contractor shall cover the fields using a totally impervious film. Soil fumigation helps reduce management costs during the growing season. Soil fumigation helps reduce the amount of pesticides applied and associated labor costs of spraying and pulling weeds.

Original Selection Process: In 2022, the DNR issued an RFQ and reviewed bids for services requested. TriEst Ag Group, Inc. was selected based on their ability to meet the needs of the State Forest Nursery. The Department solicited proposals from targeted small businesses and also published a request of proposals (RFP) on the Department of Administrative Services website.

11.1 Spirit Lake Hatchery, ADA Lift and Door – Dickinson County

The Department requests Commission approval of the following construction project:

Project Summary: The Spirit Lake Hatchery is located between Big Spirit Lake and East Okoboji Lake and is a cool water hatchery that produces over 75 million walleye fry, 100,000 six-inch walleye fingerlings, 25,000 seven-inch walleye fingerlings, and 2 million northern pike fry annually. The hatchery complex also houses the northwest district office.

The main building of the complex was constructed in 1963, and is not compliant with current accessibility standards. All accesses into the tank room viewing areas include navigation of a set of stairs, preventing some disabled visitors from accessing all that is available to able-bodied patrons. This project consists of the installation of a commercial vertical wheelchair lift and automatic sliding door to provide ADA access to the tank/hatching area from the main entrance of the facility and ADA parking areas.



11.2 Lake Manawa State Park, Pavement Maintenance – Pottawattamie County

The Department requests Commission approval of the following construction project:

Project Summary: Lake Manawa State Park is located in Council Bluffs and was dedicated in 1932. The park encompasses more than 1,500 acres including a 753-acre oxbow lake. Amenities include a paved nature trail, campground, boat ramps, a beach, concessionaire, picnic shelters, and a playground.

The existing concrete road, South Shore Drive, was constructed in the early 1970's and portions were resurfaced in the early 1990's. The road has cracking and potholes and needs rehabilitation and two intersection corners widened at 11th Street due to vehicle off-tracking. This project will employ a crack-and-seat technique, where the existing pavement is crushed in place, then covered with a 3-1/2" asphalt overlay. In addition to saving cost, this method reduces construction time, materials needed, and minimizes traffic impacts. Construction is scheduled to occur between Labor Day and November 15, 2024. The work will be staged to allow complete closure of sections of roadway during construction while still allowing



*12. Public Land Management Projects

12.1 Easement Conveyance, Pottawattamie County – City of Council Bluffs

The Natural Resource Commission is requested to approve a permanent easement for the expansion of and maintenance of the Sieck Levee in Council Bluffs, Iowa.

Project Description: The City of Council Bluffs seeks to widen the Sieck Levee located along the Missouri River increase the redundancy, resiliency, and robustness of levee systems to meet USACE criteria. The permanent Easement is for 4.12 acres. This increase in the levee width will result in the loss of a portion of the parking lot that has historically been utilized by River Valley OHV Park. The city has agreed to offset these losses by restoring the fencing and access trail, restoring the electrical service, coordinating the relocation of shelters, and reimbursing the Department for a latrine that will be removed.

12.2 Easement Conveyance, Dickinson County – Interstate Power and Light Company

The Natural Resource Commission is requested to approve an easement for installation of electrical line infrastructure at the Highway 9 Boat Ramp in Spirit Lake, Iowa.

Project Description: Interstate Power and Light Company is requesting an easement to install switchgear in the northwest corner of Highway 9 Boat Ramp. This gear will require an above ground structure to provide access to the gear. The easement will be 20 feet by 20 feet. Local Parks staff have reviewed the request and given approval.

12.3 Management Agreement, McMahon Access – Greene County Conservation Board

The Natural Resource Commission is requested to approve the Management Agreement with the Green County Conservation Board for the McMahon Access located in Greene County.

Location: This property is located 5 miles west of Jefferson in Section 32, Township 84 North, Range 31 West of the 5th P.M. in Greene County, Iowa. This access is part of the North Raccoon WMA.

Site Purpose: This 0.5-acre property contains a boat ramp that is used for boat access to the North Raccoon River.

Management History: There was a historic river access area that is ~ 1 mile south of this location. This site was determined to not be sustainable. In 2020 the County applied for a Sovereign Lands Permit to build a new boat ramp adjacent to County owned land that is a better location and more sustainable. This Permit was approved and the new ramp has been built. This agreement will cover the new boat

ramp area. As part of this agreement and the Sovereign Lands Permit, the old ramp will be removed by the county per the requirements of the Sovereign Lands Permit.

Management Agreement Term: This standard Management Agreement is with the Greene County Conservation Board for 25 years.

This agreement was approved by the Guthrie County Conservation Board on June 11, 2024.

Contract Purpose: The purpose of this contract is to enter a service contract to provide labor and equipment to complete three separate timber stand improvement projects at the Volga State Recreation Area in Fayette County. These sites have been planted with seedlings, have undergone a timber harvest, and are now ready for the residual weed trees to be cut and killed. The killing of the residual weed trees will release the planted seedlings, allowing them to be free to grow.

- The work will done in Stand 63 (27 acres), Stand 30 (23 acres), and Stands 46/95 (28.7 acres) as identified in the Forest Stewardship Plan.
- All trees 1" and larger in diameter should be cut off at the ground, with the exception of any oak, or large desirable trees utilized for roosting. The stumps of undesirable species should be treated with chemical to prevent resprouting. Double band girdling will be acceptable but not within a canopies distance from any road or trail.

This practice will remove most of the overstory, creating a dense stand of young new natural and planted regeneration.

14. Contract with Wildlife Management Institute

Commission approval is requested for a contract with Wildlife Management Institute, of Cabot, VT.

Contract Terms

Funding Source(s): Fish and Wildlife Trust Fund (100%)

Contract Purpose: The DNR is entering into a cooperative agreement with the Wildlife Management Institute (WMI) to collaboratively regional grassland conservation coordination through the Midwest Grassland Conservation Delivery Network. Grasslands are critically imperiled ecosystems in North America, but especially in the Midwest where less than 4% of historic grasslands remain. The DNR and WMI, along with other partner wildlife management agencies and non-profit organizations in the Midwest, have recognized a need for regional coordination of grassland conservation efforts in order to accomplish conservation objectives on public and private lands at the landscape scale.

The DNR and WMI will collaboratively manage the Midwest Grassland Conservation Delivery Network in partnership with the Upper Mississippi Great Lakes Joint Venture. This network will allow partners to find efficiencies, avoid duplicative efforts, leverage collective resources, and share knowledge, thereby fostering a nature of collaboration to accelerate conservation of critically imperiled grasslands.

The DNR has committed to leading this effort with WMI because of the critical importance of grasslands to our wildlife and our people. The DNR will provide logistical support for coordination meetings and technical assistance workshops and lead identification of priorities for grassland conservation in the Midwest in collaboration with other partner agencies and organizations. The WMI tasks are as follows:

Contract tasks:

- Manage the Midwest Grassland Conservation Delivery Network.
- Organize regional grassland conservation coordination meetings.
- Develop and organize regional grassland technical assistance workshops.
