Education and Experience requirements: IAC 82.6(1);

To be eligible to take an examination, an applicant must meet the minimum work experience requirements as listed below. Certain education experience approved by the IDNR may be substituted for up to one half of any work experience requirement.

CEUs: IAC 82.11

Contractors must renew their certificate every two years which ends on June 30 of even-numbered years. Continuing Education Units (CEUs) must be earned by March 31 of that year and be directly related to the subject matter of the certificate. Renewal applications are mailed to certified contractors 60 days prior to the expiration date of the certificates. Applications must be completed and returned with applicable fees listed as above. Only contractors obtaining the required CEUs are eligible for renewal of their certificate(s).

1.0	pump installer only
0.2	well plugging contractor (If notified by the IDNR)

Conditions

- Continuing education must be earned during two-year periods between April 1 and March 31 of even-numbered years.
- A certified well contractor holding well driller certification or both well driller and pump installer certifications must earn 1.6 units or 16 contact
- hours during each two-year period.
- A certified well contractor holding only pump installer certification must earn 1.0 units or 10 contact hours during each two-year period.
- A well plugging contractor may be required to earn 0.2 units or 2 contact hours during each two-year period as determined by the department, provided the well plugging contractor is notified of the requirement at the beginning of the renewal period.
- Newly certified (previously uncertified) well contractors who are certified after April
 1 of even-numbered years will not be required to earn CEUs until the next twoyear period.
