**PETITION FOR WAIVER FROM WELL SEPARATION RULES**

Pursuant to 561 Iowa Administrative Code Chapter 10, Waivers from Administrative Rules, a petitioner must provide comprehensive justification of a proposed request for a waiver to an administrative rule as adopted by the Department of Natural Resources (DNR).

This form will assist you in providing all pertinent information that is necessary for the DNR to grant a waiver. The form must be submitted to the DNR and must contain an adequate amount of factual and concise information. The obligation rests with the petitioner to provide convincing evidence to justify the granting of a waiver. You may provide additional information or attach additional pages if needed. The DNR reserves the right to require additional information to further support request for a waiver. While the DNR is required to consider a request for waiver, it is not required to grant a waiver even if all requested information is provided.

Petitions will be evaluated by the DNR. The DNR reserves the right to place any condition on the waiver. If information is not inclusive, concise, or does not adhere to the justifications and/or proof the petitioner has submitted, the waiver may be denied. Upon review, the DNR will grant or deny the waiver in writing.

The petition will be reviewed by DNR staff to evaluate whether the proposed construction meets the standard of “substantial equivalent performance to the separation distance.” Specifically, the DNR will evaluate whether or not the private well is acting or has the potential to act as a direct conduit to an aquifer.

Use of this form is not required, but your request will be automatically denied if you fail to submit all the information described in this form.

All petitions for a waiver should be completed, signed and submitted to the DNR. One complete copy shall be submitted to the Office of the Director: 6200 Park Ave Ste 200, Des Moines IA 50321. A second complete copy shall be submitted to the Iowa DNR, AFO Program, ATTN: AFO Engineer Iowa DNR - FO3, 1900 N Grand, Gateway North Mall, Spencer IA 53101. A third copy must be submitted to the appropriate Field Office, see link to addresses below.

2. **\*Well construction details:**
  - a. Provide a drillers log or reference online information: Check the Iowa DNR’s GEOSAM database (<http://ifis.iowafloodcenter.org/ifis/more/geosam/>) to determine if well construction details are available online. Private well tracking numbers may also provide staff with useful details.

The DNR shall grant or deny a petition for a waiver with 120 days of the receipt of the petition. Failure of the DNR to grant or deny a petition within the required time period shall be deemed a denial of that petition by the DNR. A waiver is void if the material facts are not true or if facts have been withheld. The DNR reserves the right to cancel a waiver at any time if the DNR finds that the facts as stated in the request are not true, material facts have been withheld, the alternative means of compliance provided in the waiver have failed to achieve the objectives of the statute, or the requester has failed to comply with the conditions of the waiver.
