

Special 2019 Antlerless Deer Hunt Honey Creek State Park

Permitted Weapon: <u>Muzzleloader or Shotgun</u> Hunting Dates: December 28th & 29th, 2019

Information (Please read before completing application):

- License applications will be accepted from September 10 November 30th, 2019. Those received after November 30th will be rejected.
- 2. 25 applications will be drawn and licenses issued to *lowa residents* for the hunting season and dates indicated above. Each license issued from the drawing will be for one (or more) antlerless tags. If you are a successful applicant, you will purchase at least one tag.
- 3. Only one application per individual per envelope will be accepted (Exception: 1 adult + 1 minor child, 12 years or older. A child must have completed a Hunter Education Course to participate in this special hunt.)
- 4. The license fee is \$28.50 for the first license tag, unless a previous antlerless tag has been purchased, then the first purchased tag is \$13.00. You will need to purchase your tags after attending safety meeting. Please do not send checks to the park office.
- 5. The harvest is restricted to antlerless-deer only.
- 6. Only persons with a special Honey Creek Muzzleloader or Shotgun deer license will be permitted in the State Park during the above dates.
- 7. Successful applicants will be notified by telephone or e-mail; and are required to attend a one-hour safety and orientation meeting prior to being issued a special Honey Creek Muzzleloader or Shotgun deer license. Returning hunters are not required to attend safety meeting and will be given a hunter selection form that is required to be shown when purchasing tags. The tags are required to be purchased through the Honey Creek Resort front desk. A hunter selection form must be accompanied with the hunter when buying the license from Honey Creek Resort. Selected hunters will be given this form either through the mail, if a returning hunter, or after the safety meeting, if a new hunter.
