*\*The Iowa Department of Natural Resources is required to collect social security numbers from all persons obtaining a hunting, fishing or other recreational license under section 252J.8 of the Code of Iowa and 42 US Code 666(a)(13). Your social security number will serve as your principal identification number to determine your eligibility for licenses. It will be provided to law enforcement agencies and the Iowa Child Support Collection Unity to establish, modify, and enforce child support obligations and to collect liabilities owed to the state or a state agency. It **WILL NOT** appear on your license.*

#### QUALIFICATIONS:

The Department of Natural Resources will issue an annual fishing or combination hunting and fishing license to a resident of Iowa who served in the armed forces of the United States on active federal service (other than training) in accordance with Iowa Code 35.1. To qualify, the law requires that the veteran has served on federal active duty and is also a current resident of Iowa and has met our qualifications of residency, including being a resident of Iowa for at least 90 days prior to applying for this license. #### ACKNOWLEDGEMENTS

- This application will be processed and I will be notified when I can purchase my license at any license vendor or online.
- This application will not need to be filled out more than once, but I will need to purchase my license annually once this certification has been added to my account (License fee: \$7.00, includes administrative fee).

#### REQUIRED DOCUMENTATION

- Copy of DD214 - #2 or higher (must show characterization such as Honorable or General, Under Honorable Conditions).
- Copy of Hunter Safety Certificate (*If you were born after December 31, 1971, and do not have hunter safety noted on your account you will only be allowed a fishing license.*)

**NOTE:** This license **does not** include any additional fish and wildlife fees. You must still purchase the appropriate fish and wildlife fees, including the habitat stamp, **each** year.

I hereby apply for an Iowa Resident Armed Forces Veteran's Annual Hunting/Fishing license. I understand that providing false information automatically makes this application invalid. Therefore, any and all licenses issued as a result will also be invalid and may be subject to penalties for making a false entry in a public record under Iowa Code 714.8(4), and for hunting, fishing, or trapping without a valid license under Iowa Code 483A.
