\*The Iowa Department of Natural Resources is required to collect social security numbers from all persons obtaining a hunting, fishing or other recreational license under section 252J.8 of the Code of Iowa and 42 US Code 666(a)(13). Your social security number will serve as your principal identification number to determine your eligibility for licenses. It will be provided to law enforcement agencies and the Iowa Child Support Collection Unity to establish, modify, and enforce child support obligations and to collect liabilities owed to the state or a state agency. It **WILL NOT** appear on your license.

**QUALIFICATIONS:**

The Department of Natural Resources will issue the licenses and tags listed below to a resident of Iowa who served in the armed forces of the United States on active federal service (other than training), who was disabled during that veteran's military service. To qualify due to disability, the law requires that the veteran be entitled to a service connected disability rating under the United States Code, Title 38, Chapter 11 and who also is a current resident of Iowa and have met our qualifications of residency, including being a resident of Iowa for at least 90 days prior to applying for this license. **Hunter Education Requirement:** Hunters born after January 1, 1972 must complete a Hunter Education course to obtain an Iowa hunting license. If this is your first hunting license in Iowa please include a copy of your Hunter Safety Certificate along with your application. We accept Hunter Safety Certificates from other states.

- One (1) extra Any Deer tag for any firearm season (Tag fee: \$33.00) (Note: Tag available on August 15 annually)

**REQUIRED DOCUMENTATION**

Copy of DD214 - #2 or higher (must show characterization such as Honorable or General, Under Honorable Conditions).

Copy of a current letter provided by the U.S. Department of Veterans Affairs which indicates that you are entitled to a service connected disability rating.

Copy of Hunter Safety Certificate (*Only required if it's not noted on your account and you plan to purchase a hunting license.*)

\*\*Duplicates of a previously issued license may be purchased from any license agent for \$4.50.

**NOTE:** This license **does not** include any additional fish and wildlife fees. You must still purchase the appropriate fish and wildlife fees **each** year.

I hereby apply for an Iowa Resident Veteran's lifetime licenses and tags. I understand that providing false information automatically makes this application invalid. Therefore, any and all licenses issued as a result will also be invalid and may be subject to penalties for making a false entry in a public record under Iowa Code 714.8(4), and for hunting, fishing, or trapping without a valid license under Iowa Code 483A.
