<b>1) HAZARDOUS WASTE GENERATOR FEE (Due regardless of exemptions in #4)</b>		
1a) Multiply each ton (up to 2,500) of hazardous waste transported off site from where the hazardous waste was generated by \$10.00 and enter that amount. <i>If less than ¼ ton check this box</i> <input type="checkbox"/> <i>and do not enter a fee.</i>		
1b) Multiply each ton of hazardous waste that was sent to a hazardous waste disposal facility in Iowa by \$40.00 and enter that amount. See field 8 on Uniform Hazardous Waste Manifests to determine destination.		
1c) Multiply each ton (up to 500 tons) of hazardous waste treated or destroyed at the site of generation to render the hazardous waste non-hazardous by \$2.00 and enter that amount.		
<b>2) HAZARDOUS WASTE TREATMENT, STORAGE, OR DISPOSAL FEE (Due regardless of exemptions in #4)</b>		
2a) Multiply each ton (up to 2500) of hazardous waste transported from the disposal facility site by \$10.00 and enter that amount. If less than ¼ ton check this box <input type="checkbox"/> and do not enter a fee.		
2b) Multiply each ton of hazardous waste placed, deposited, dumped, or disposed of onto or into the land at the disposal facility by \$40.00 and enter that amount.		
2c) Multiply each ton (up to 500 tons) of hazardous waste treated or destroyed at the disposal facility to render the hazardous waste non-hazardous by \$2.00 and enter that amount.		
<b>3) HAZARDOUS WASTE TRANSPORTER FEE (Due regardless of exemptions in #4)</b>		
<b>4) EXEMPTIONS</b>		
You are exempt from payment of fees in sections <b>1a, 1b, 1c, and 2a, 2b, 2c</b> for any portion of your waste that meets the following criteria. <b>If no tonnage fees are recorded in 1a, 1b, 1c, or 2a, 2b, 2c there must be an exemption checked below to waive those tonnage fees.</b> Check all boxes that apply.		
<input type="checkbox"/> The hazardous waste is recycled, reclaimed or reused for energy or materials. <input type="checkbox"/> The hazardous waste is transformed into new products that are not considered wastes. <input type="checkbox"/> The hazardous waste is created or retrieved because of remedial action at a hazardous waste or hazardous substance disposal site. <input type="checkbox"/> The waste is the influent to a wastewater treatment facility that is subject to regulation under section 33 U.S.C. 1317(b) or 33 U.S.C. 1342. <input type="checkbox"/> A hazardous waste, which, due to its intrinsic physical, chemical or biological composition, degrades, decomposes or changes physical characteristics so as to be rendered or considered non-hazardous without any form of external mechanical, physical or chemical treatment being introduced. However, such change to a non-hazardous nature must occur within 24 hours of the generation of the hazardous waste before the exemption granted in this paragraph is applicable.		
5) Add amounts entered in sections 1, 2 and 3 and enter the fee due. If you do not owe a fee, enter \$0.00.		
6) Enter 15% penalty if DNR will receive the fee after the April 15, 2026 deadline.		
7) Add amounts in 5 and 6 and enter the total amount due.

## INSTRUCTIONS

Section 455B.424 of the Iowa Code requires small and large quantity generators and anyone that treats, stores, disposes of or transports hazardous waste in Iowa to complete the enclosed Hazardous Waste Activities Form and pay the appropriate fee. You are receiving this form because the US Environmental Protection Agency (EPA) regulates your facility under the Hazardous Waste Management section of the Resource Conservation and Recovery Act (RCRA).

**Fees entered on the form are based on data provided by the US Environmental Protection Agency (EPA).** Contact EPA Region 7 at [Iowa.Notifications@epa.gov](mailto:Iowa.Notifications@epa.gov) to make corrections related to addresses, ownership, operating status, or EPA can also answer questions about your EPA Hazardous Waste ID Number.

Fees are due if the business was operated for any portion of the previous calendar year. The form must be completed, signed, and returned with any fee due by April 15, 2026. A 15% penalty will apply to all fees received after April 15.

### **Section 1 – Hazardous Waste Generator Fee (Fee due regardless of exemptions in Section 4)**

Generators: a person (to include a business/corporate entity) whose act or process produces hazardous waste identified or listed in 40 CFR Part 261. Every site that generates hazardous waste must have an EPA registration number. If a generator keeps hazardous waste on site for more than 90 days, they become an “operator” of a storage facility (see Section 2 below). This section is for those facilities who have been determined by EPA to be a generator of hazardous waste. There is no exemption for this generator fee. The fees are broken down into the categories listed below. The generator fee will automatically be pre-printed in the appropriate field on the form per information received from the EPA.

**Small Quantity Generators - \$25.00** (facilities generating between 220 and 2200 pounds in any calendar month)

**Large Quantity Generators - \$250.00** (facilities generating greater than 2200 pounds in any calendar month)

**Very Exempt Small Quantity Generators - not required to report activities or pay a generator fee** (facilities generating less than 220 pounds all months in a calendar year).

In fields 1a, 1b, and 1c, tonnage fees are assessed and determined by the disposition of the hazardous waste generated. **If no tonnage fees are recorded in fields 1a, 1b, or 1c, you must have the qualifying exemption(s) marked in Section 4** to waive those tonnage fees for your facility.

### **Section 2 – Hazardous Waste Treatment, Storage, or Disposal Facility (TSD) Fee (Fee due regardless of exemptions in Section 4)**

Treatment/Storage/Disposal (TSD) Facility: can be either of these or all at once; requires a special permit from the EPA, which can either be for the lifetime of the facility or for no more than 10 years (the latter includes land disposal, storage, or incinerator facilities). This section is for those facilities that have been determined by the EPA to treat, store or dispose of hazardous waste. There is an annual \$25.00 fee for Hazardous Waste TSD facilities. There is no exemption for this TSD fee. This TSD fee will automatically be pre-printed in the appropriate field on the form.

In fields 2a, 2b, and 2c, tonnage fees are assessed and determined by the disposition of the hazardous waste received. **If no tonnage fees are recorded in fields 2a, 2b, or 2c, you must have the qualifying exemption(s) marked in Section 4** to dismiss your facility from these tonnage fees.

### **Section 3 – Hazardous Waste Transporter Fee (Fee due regardless of exemptions in Section 4)**

Transporters: handles and moves hazardous waste, which is shipped off-site, from where it was generated, stored, or temporarily disposed of. A transporter can store hazardous waste at its facility for up to 10 days without becoming a storage facility (see Section 2). This section is for those businesses that have been determined by the EPA to transport hazardous waste. There is an annual \$25.00 fee for Hazardous Waste Transporters. There is no exemption for this Transporter fee. This Transporter fee will automatically be pre-printed in the appropriate field on the form.

### **Section 4 – Exemptions**

This section is for exemptions on tonnage fees assessed in 1a, 1b, 1c, 2a, 2b, and 2c for any portion of the hazardous waste that meets the criteria listed. More than one exemption box may be checked if it applies towards the disposition of the waste generated.
