**Contract Purpose:** To assist 13 lowa communities with planning and managing their urban tree resources, development of response to the presence of Emerald Ash Borer and other tree pests and problems. As a part of the project each eastern lowa community included in the contract will receive an inventory of street and park trees, a visual survey of forest health symptoms, a summary of benefits those trees, and an urban forest management plan. Tasks include:

- Inventory street and park trees in identified communities. Collect data for each tree that includes all require categories for data collection, i.e., GPS derived locations for each tree and data elements for each tree.
- Visually survey all trees for signs and symptoms of invasive pest and disease in the identified communities, return data to DNR in shapefile format via e-mail.
- Calculate the benefit of the street and park trees using the most current version of i-Tree and create maps of the trees for each urban forest management plan.
- Finalize urban forest management plans for the identified communities and submit plans to DNR for approval.
- Presentation of the urban forest management plans to each community.

### Communities include:

This process was done annually since 2012 for 400 other communities in total. These inventories and plans have aided communities with current information to make tree care and budget decisions. The data collected in these have help prioritize removal and treatment of ash trees as well as monitored for pests like walnut twig beetle that is necessary for lowa to continue international sale of wood products.

**Selection Process Summary:** The Department solicited proposals from 250 in-state arborists and national tree inventory companies. Proposals were scored based on the criteria as described in the RFP which included cost of service and experience conducting street tree inventories and writing urban forestry management plans which includes work plan, past work projects, capacity of respondent and mechanism for GIS collection.

# 10. Chapter 33, Resource Enhancement and Protection Program: County, City, Private Open Spaces and Conservation Education Grant Programs –Competitive Grant Program Selection Criteria

The Commission is requested to approve the competitive grant program selection criteria for Chapter 33, Resource Enhancement and Protection Program: City Parks & Open Spaces and County Conservation Grants.

**Purpose:** Chapter 33.16(3), 33.17(4) and 33.18(5) require the review and selection committees to establish criteria and scoring systems to be utilized in project evaluation for approval by the Director and the Natural Resource Commission. REAP is funded through a state appropriation and, by law, those funds must protect Iowa's natural resource heritage of air, soils, waters, and wildlife for the benefit of present and future citizens.

**Recommendation:** The REAP City Parks & Open Spaces and County Conservation Review and Selection Committees recommend utilizing the same scoring system for both grant opportunities. The Private Open Spaces Cost-Share Review and Select Committee recommends a similar scoring system but specific to the nature of Private Open Spaces Cost-Share grant which does not include development. The rubrics presented will allow for improved transparency for applicants as they prepare applications and for a retrospective review on areas which could be improved on in future applications if not selected for funding.

#### 11.1 Chapter 17 Lease Renewal, Royal Retreat LLC - Dickinson County

The Natural Resource Commission is requested to approve the renewal of Chapter 17 Lease (Lease for use of State Owned Land) Number 64-R with Royal Retreat LLC.

**Location:** The lease covers an area of dedicated public land 15' x 10' and an area 3' x 10' adjacent to Lot 15, in Block 35 of Triboji Beach Addition in Dickinson County, Iowa.

**Site Purpose:** The site contains a concrete patio and steps maintained by the Tenant.

Lease History: The location has been under lease since 2011.

**Lease Fee and Term:** The annual fee is \$150.00 with a condition that the fee may be adjusted to comply with adopted administrative rule changes that affect lease fees. The term of the lease will be five years.

### 11.2 Chapter 17 Lease Renewal, Guardian Holdings, LLC - Scott County

The Natural Resource Commission is requested to approve the renewal of Chapter 17 Lease (Lease for use of State Owned Land) Number 70-R with Guardian Holdings, LLC.

**Location:** The lease covers an area with 360 feet of frontage and 58 feet of depth located at Mississippi River mile 487.0 in Section 27, Township 78 North, Range 4 East of the 5<sup>th</sup> P.M. in Scott County, just north of Bettendorf.

**Site Purpose:** The site contains steel sheet pile retention walls, a concrete platform, and two moorings for the purpose of loading and unloading commodities to and from barges.

Lease History: The location has been under lease since 1987.

**Lease Fee and Term:** The annual fee is \$1,292.89 with a condition that the fee may be adjusted to comply with adopted administrative rule changes that affect lease fees. The term of the lease will be five years.

### 11.3 Boundary Resolution, Harrison County – Loess Hills State Forest

The Natural Resource Commission is being requested to approve a Quit Claim Deed transfer to JAR Farms, LTD for 2.87 acres and a Quit Claim Deed transfer to Myrna J. Thomas for 3.15 acres in Harrison County, Iowa.

The Loess Hills State Forest, Little Sioux Unit , containing approximately 3,634 acres, is located one mile east of Little Sioux in Harrison County. On November 10, 2008, William and Shirley Harl ("Harls") executed an offer to sell certain real estate for the sum of \$156,000 to the DNR comprised of the entirety of the S½ of the SW¼ of Section 17, Township 81 North, Range 44 west of the P.M. in Harrison County, lowa, totaling 80 acres ("Property"). The sales price was based upon an appraisal secured by the department that valued the 80-acre parcel at \$1,950 an acre for a total of \$156,000.

At the time of the purchase, the Harls were record owners of that portion of the Property on both the East and West side of the centerline of Larpenteur Memorial Road ("Road"). At the time of the purchase of the Property by the State of Iowa, the Harls retained certain property West of and adjacent to the purchased Property known as the N ½ of the SE ¼ of the SE ¼ of Section 18, Township 81 North, Range 44 West of the 5<sup>th</sup> P.M. and David and Myrna Thomas owned certain property West of the purchased Property known as the S ½ of the SE ¼ of Section 18, Township 81 North, Range 44 West of the 5<sup>th</sup> P.M. (See Exhibit B).

However, the Harls understood the 80-acres they were selling to be located entirely East of the centerline of the Road, but during the acquisition process, the DNR reality staff reached out to the Harrison County Auditor to check the boundaries and were provided a map that showed that a small portion of the Property was West of the Centerline of the Road, and thus, included all of the Road (See Exhibit B). Nonetheless, the DNR decided to move forward with the purchase of that portion of the Property East of the centerline of the Road even though this parcel was necessarily less than the full 80-acres.

The purchase of the Property was closed on the 29<sup>th</sup> day of December 2008. However, instead of receiving a deed for that portion of the Property East of the centerline of the Road, the State was inadvertently deeded the entirety of the Property.

Subsequently, the Harls sold their retained property on the West side of the Road in 2017 to JAR Farms, LTD. This parcel included an acreage that was located West of the Road. In 2020, JAR Farms, LTD completed a survey to parcel off the house to sell it. During this survey it was discovered that the section line between Sections 17 and 18, contrary to the to the assessor map set out at Exhibit B, was actually 162 feet West of the centerline of the Road. According to this survey, the State was inadvertently deeded the acres West of the centerline of the Road (See Exhibits A and C), including a portion that the Harls did not think they owned but thought that Myrna Thomas owned. After acquiring the entirety of the Property, the State through the DNR never occupied or took any possessory interest in that portion of the Property West of the centerline of the Road, and JAR Farm, LTD and Myrna Thomas have been using and occupying that portion of the Property adjacent to their property in neighboring Section 18.

As JAR Farm, LTD and their predecessors and Myrna Thomas have been possessing and occupying that portion of the Property West of the centerline of the Road adjacent to their Section 18 property since the State was deeded the Property in 2008, they are seeking Quit Claim Deeds from the State for that portion of the Property West of the centerline of the Road totaling 2.87 acres for JAR Farms, LTD and 3.15 acres, more or less, for Myrna J. Thomas. Once the corrective deeds are recorded, the State will be left with approximately 74 acres of property East of the centerline of the Road.

The governor on behalf of the State has the ability to issue a Quit Claim Deed per Iowa Code section 9G.10 – Quitclaim deeds:

Whenever the governor is satisfied by proper record evidence that any tract of land which may have been deeded by virtue of any donation or sale to the state is not the land intended to have been described, and that an error has been committed in making out the transfers, in order that such error may be corrected, the governor is authorized to quitclaim the same to the proper owner thereof, and to receive a deed or deeds for the lands intended to have been deeded to the state originally.

# Goodman and Thomas Quit Claim Map Harrison County




# 13. Large Construction Item

**13.1** Lake Manawa State Park, Rock Reef Habitat and Outlet Pipe Work – Pottawattamie County The Department requests Commission approval of the following construction project:

**Project Summary:** Lake Manawa State Park was dedicated in 1932. It is located within the city limits of Council Bluffs. The park is 1,529 acres in size that includes a 785-acre Missouri River oxbow lake. Amenities include a beach, beach concession, three boat ramps, various picnic shelters, two playgrounds, walking trails, bikes trails, and a youth campground.

Mosquito Creek is located to the east of Lake Manawa and has a watershed of more than 200 square miles. In 1955, a diversion structure and 48" reinforced concrete subsurface pipeline was constructed to partially direct flow from Mosquito Creek to Lake Manawa by gravity. In 2023, it was observed that water was boiling up through the shoreline armoring at the outlet location on the lake. It is believed that either the CMP outlet section of the pipe has failed or rock has migrated into the outlet pipe opening, causing a significant obstruction and reduced flow into the lake. Because shoreline access is difficult, this project will utilize bargemounted equipment to clean out the riprap from the pipe outlet. Once free of obstruction, a 40-foot length of HDPE pipe will be slid halfway into the diversion pipe and anchored. Riprap will be replaced along the shoreline.

Additionally, this project will utilize a barge to place approximately 1,140 tons of riprap in 15-ton piles localized in four regions of the lake. These piles will provide improved habitat for game fish.

### 13.2 Rathbun Hatchery, Pond Liner Replacement – Appanoose County

The Department requests Commission approval of the following construction project:

**Project Summary:** The Rathbun Fish Hatchery is located immediately below the Rathbun Lake dam and was constructed in the late 1970's. It is a warm water fish hatchery, producing more than 100,000 eight-inch fingerling catfish, 75,000 two-inch fingerling catfish, 70 million walleye fry, 225,000 two-inch walleye fingerlings, and 175,000 nine-inch walleye fingerlings annually. On request, Muskellunge are overwintered and other species are raised as needed. Fish produced at this facility are stocked statewide in Iowa ponds, rivers, and lakes.

The outdoor facilities include ten 1-acre ponds and six 0.1acre ponds. Each pond has a polypropylene liner that was installed in 1999, and they have reached the end of their design life. This project will remove and replace the liners with



EPDM (ethylene propylene diene terpolymer). This project will also replace various water control valves that service the ponds.


# 13.3 Saylorville Wildlife Management Area, Upper Fraser Boat Ramp Renovation – Boone County

The Department requests Commission approval of the following construction project:

**Project Summary:** The Saylorville WMA is 11,013 acres in size and stretches among Boone, Dallas and Polk counties. The area consists of the Des Moines River valley from Highway 17 in Polk County to the City of Fraser, and includes timber, upland, lake habitat, and numerous parking lots and river boat ramps.

**Project Description:** The Upper Fraser Boat Ramp is located on the Des Moines River in Boone County near Fraser, Iowa. The existing boat ramp is at risk due to the erosion of the existing riverbank upstream of the boat ramp. The existing gravel parking lot has also experienced flood damage. This project will install three weirs upstream of the existing boat ramp to stop the bank erosion and protect the boat ramp. Damaged areas of the parking lot will receive new granular surfacing and part of the existing gravel parking area will be converted to a concrete ADA parking space and an ADA concrete sidewalk connection to the boat ramp. The existing concrete boat ramp will also have a new concrete approach installed in place of the existing gravel approach.

**Property Description:** The subject property is located in the globally unique, Loess Hills of western lowa in Monona County, approximately 6 miles northeast of Little Sioux, about 50 miles north of Council Bluffs and around 60 miles south of Sioux City. This former Boy Scout Camp is a single block of mostly forested land. The forest species are predominately hardwoods of oak and hickory. The property consists entirely of Loess Hills topography, with a mix of ridgetop, hillside and valley areas. A 20-acre lake is located in the heart of the property. Access is provided from Larpenteur Memorial Road on the West and County Highway E60 on the Northeast. This parcel will connect three separate edges of the Loess Hills State Park, Preparation Canyon Unit, which is currently 4,068 acres. This property is located in the Loess Hills Bird Conservation Area, which is part of the Central migratory flyway, and has documented 249 avian species including 80 lowa species of greatest conservation need. The property is designated as a Audubon Important Bird Area and is located along the Loess Hills Scenic Byway. The Loess Hills have a rich archaeological heritage. Several Native American tribes lived in the area (the Omaha, Ponca, Ioway, Pottawattamie and the Sioux). A ceremonial burial area for the Sioux is located on a hilltop prairie facing the Missouri floodplain on the property.

**Purpose:** This acquisition is an aesthetic tract that will protect one of the largest contiguous regions of forest in western lowa. It will provide for public access to outdoor recreation and hunting opportunities. This property has about 26 miles of hiking trails that will connect to existing Loess Hills State Forest trails, resulting in over 100 miles of connected public hiking trails. This addition to the Preparation Canyon Unit of the Loess Hills State Forest will provide for land conservation of the forest, water quality protection for the watershed, and wildlife habitat while maintaining the continuity of the forest. This property will provide habitat for several state and federal threatened and endangered species, such as the plains pocket mouse (state endangered), Dusted skipper, Ottoe skipper, Hickory hairstreak (special concern), bullsnake, narrow-leaved milkweed and scarlet globemallow.

**Contract Purpose:** High resolution panoramic imagery of the Des Moines, Boone, and Lizard Creek Water Trails (similar to Google Street View) is needed to greatly enhance our understanding of these recreational trails. The panoramic imagery captured as a part of this contract will help the DNR and our partners gain an excellent understanding of the river resource, identifying potential hazards, such as, major log jams or areas prone to major log jams, and other hazards. It will also allow us to identify needed improvements, if any, at the 64 public access sites along each of the waterways. Further, this imagery will be hosted ongoing and available free to the public to serve as a tool for kayak or canoe trip planning and decision making.

In 2024, the DNR River Programs contracted with Terrain360 LLC to capture panoramic imagery of nearly 200 miles of the Little Sioux River and 30 water accesses. The results were impressive. This contract is for Terrain360 LLC to capture the imagery for all the water trails on the Des Moines River, as well as the Boone River and Lizard Creek water trails.

Contract tasks Include:

- Launch Kick-off meeting and attend three additional meetings with DNR
- Capture on-water high resolution panoramic imagery of 248 miles of water trails
- Capture on-land high resolution panoramic imagery of the 64 water access sites
- Render and host the imagery for planners and public access.
- Develop online interactive map/virtual tour experience

#### **Amendment Purpose:**

Backbone State Park currently has a septic tank and sand filter that treats wastewater generated by the cabins and beach area. A new NPDES permit, with updated discharge limits, has been issued for this system. The allowable ammonia concentration of the discharge has been lowered and a new requirement for eliminating E. Coli has been added to the permit. The original contract was for Shive-Hattery to design a tertiary treatment system to work inline with the existing septic tank and sand filter to address ammonia and E. Coli. However, during the review of the existing facilities, it was found that the septic tank and sand filter need replacement. This amendment will add design services to the original contract to include the design of a replacement septic tank and sand filter.

**Original Selection Process:** The Department solicited proposals from targeted small businesses and also published a request of proposals (RFP) on the Department of Administrative Services website. Proposals were scored based on the criteria as described in the RFP, which included their ability to complete the scope within the desired timeline, comprehensive work plan, description and quality of previous and applicable work experience, and cost. Shive-Hattery was selected out of a pool of three submitted proposals.
