Dear Mr. Langel:

The Iowa Department of Natural Resources in accordance with Subrule 567—64.2(9)c of the Iowa Administrative Code has approved your October 23, 2003 request for a variance from the Department Rule 567—64.2(9)b and Chapter 17.3.5.3 of the Iowa Wastewater Facilities Design Standards, which requires a minimum aeration rate for mixing of 20 cubic feet per minute (cfm) per 1,000 cubic feet of volume for sludge holding lagoons. Based on the documentation presented by the design engineer, it is the determination of this Department that satisfactory justification has been presented to warrant the granting of a variance to the City of LeMars for eliminating the aeration rate required for mixing. However, in the future if the Department determines that the proposed facility is causing any odor or other operational problems due to the absence of aeration and mixing, the City shall a obtain a construction permit and install aeration equipment as required by paragraph 17.3.5.3 of the Iowa Wastewater Facilities Design Standards within 18 months of written notification

This decision is based on our review of justification presented to support the request and our concurrence that the resulting project will provide substantially equivalent effectiveness as would be provided by technical compliance with the design standard on this issue.
