**Basic Intent of Rule:** Chapter 33 defines the processes and requirements for entities to receive funding through the private cost-sharing funds in the county, city, private open spaces and conservation education grant programs of the Resource Enhancement and Protection Fund (REAP). REAP is funded through a state appropriation and, by law, those funds must protect Iowa's natural resource heritage of air, soils, waters, and wildlife for the benefit of present and future citizens.

As part of 2024 Iowa Acts, Senate File 2385, effective July 1, 2024, the Resource Enhancement and Protection (REAP) Conservation Education Program funds are now administered by the Department and REAP Coordinator instead of by the Conservation Education Program Board. Due to this change, the Department is undertaking rulemaking to create a review and selection committee that will assist the REAP Coordinator in the award of Conservation Education Program grants and disbursement of funds.

**NOIA:** The Notice of Intended Action (NOIA) was approved by the Commission on March 13, 2025. The NOIA was published in the Iowa Administrative Bulletin on April 2, 2025, as ARC 10137. Two public hearings were held on April 23<sup>rd</sup> and May 7<sup>th</sup>, 2025.

**Changes from NOIA:** One member of the public attended the hearing but no formal comment was received. No changes to the rulemaking were made from the published Notice of Intended Action.

#### NATURAL RESOURCE COMMISSION[571]

#### **Adopted and Filed**

The Natural Resource Commission (Commission) hereby adopts Chapter 33, "Resource Enhancement and Protection Program: County, City, Private Open Spaces and Conservation Education Grant Programs," Iowa Administrative Code.

#### Legal Authority for Rulemaking

This rulemaking is adopted under the authority provided in Iowa Code section 455.A.19.

# State or Federal Law Implemented

This rulemaking implements, in whole or in part, Iowa Code chapter 455A and 2024 Iowa Acts, Senate File 2385.

# Purpose and Summary

During the 90th General Assembly, 2024 Iowa Acts, Senate File 2385, was enacted. This legislation eliminated the Conservation Education Program Board. As of July 1, 2024, the Resource Enhancement and Protection's (REAP) conservation education funds are now administered by the Department of Natural Resources (Department) and the REAP Coordinator instead of by the Board. Due to this change, the Department is promulgating rules to award the conservation education program grant funds, which includes creating a review and selection committee.

#### Public Comment and Changes to Rulemaking

Notice of Intended Action for this rulemaking was published in the Iowa Administrative Bulletin on April 2, 2025, as ARC 10137. In-person and virtual options for public hearing were offered. The in-person option was held on April 23, 2025, at 1:00-3:30 PM at DNR Headquarters, 6200 Park Avenue, Suite 200, Des Moines, Iowa and the virtual option was held May 7, 2025 from 1:00 – 3:30 PM via Zoom.

One member of the public attended the hearing but no formal comment was received. No changes to the rulemaking were made from the published Notice of Intended Action.

#### Adoption of Rulemaking

This rulemaking was adopted by the Natural Resource Commission on June 12, 2025.

# Fiscal Impact

This rulemaking has no fiscal impact to the state of Iowa.

# Jobs Impact

After analysis and review of this rulemaking, no impact on jobs has been found.

#### Waivers

Any person who believes that the application of the discretionary provisions of this rulemaking would result in hardship or injustice to that person may petition the Commission for a waiver of the discretionary provisions, if any, pursuant to 571-Chapter 11.

#### Review by Administrative Rules Review Committee

The Administrative Rules Review Committee, a bipartisan legislative committee which oversees rulemaking by executive branch agencies, may, on its own motion or on written request by any individual or group, review this rulemaking at its regular monthly meeting or at a special meeting. The Committee's meetings are open to the public, and interested persons may be heard as provided in Iowa Code section 17A.8(6).

#### *Effective Date*

This rulemaking will become effective on August 13, 2025.

The following rulemaking action is adopted:

ITEM 1. Amend subrule 33.4(3) as follows:

**33.4(3)** Application deadlines are the same for county, city, and private open space grant programs. Conservation education program application deadlines are offered annually but not on the same schedule as the county, city, and private open space grant programs. Applications for all REAP grant programs will be reviewed and projects selected for funding at least once per year. The department shall publish on its website the date and time for submitting a funding proposal, providing at least 90 days' notice. Applications must be submitted to the department as described on the website.

ITEM 2. Amend rule 571—33.19(455A) as follows:

#### 571—33.19(455A) Conservation education program policy.

<u>33.19(1)</u> Grants and agreements. The conservation education program board shall constitute a long-term integrated effort to support conservation education for Iowa educators and students through formal and nonformal education projects and programs by means of competitively awarded grants and cooperative agreements. To support this policy, the board may establish guidelines from time to time to direct applicants to priority areas for funding and shall give preference to grants that meet these guidelines. The board may provide funding for activities that expand the impact of the project and provide accessibility for widespread adoption of programs for implementation by others. The board may provide funding for tracking of project implementation and evaluation.

**33.19(1)** *Conservation education program board.* The board will review and amend, as needed, the review and selection criteria for competitive grants and policies of conduct.

**33.19(2)** *Definitions.* The following definitions shall apply to this division:

#### "Board" means REAP conservation education program board.

"Conservation education programs" means programs developed for formal (K-12 students), nonformal (preschool, adult and continuing education) and higher education (postsecondary and adult) programs, within the subject areas of natural resource conservation and environmental protection.

*"Dissemination grant"* means funds deployed for the purposes of executing projects previously funded by REAP conservation education program funds that were successful in execution and have transferability to other educators and conservation programs.

*"Dissemination plan"* means the required documentation for projects greater than \$10,000 funded by the REAP conservation education program funds. A dissemination plan contains specific details of the project, including expected outcomes essential for the uptake and use by educators and conservation programs.

*"Educator"* means any person who teaches environmental/conservation education. This may apply to certified teachers, governmental or private naturalists, education specialists, or others so determined by the <u>board department</u>.

"*Environmental/conservation education materials*" means materials that are developed or produced that provide knowledge, skills, processes and strategies that enhance Iowa citizens' understanding of natural resources conservation and environmental issues.

"Stipends for Iowa educators who participate in innovative conservation education programs" may include tuition costs; acceptable food and lodging costs; substitute teacher costs; mileage expenses or separate allowances when applicable for educators to attend boardapproved approved environmental/conservation education workshops, in-service programs and conferences; and other costs as approved by the <u>board department</u>.

ITEM 3. Amend rule 571—33.20(455A) as follows:

**571—33.20(455A)** Eligibility for funds. In years in which funds are made available, grant applications may be submitted by institutions of higher learning; government agencies, including local school districts; nonpublic private schools and home schools; area education agencies; day cares; and organizations; and individuals with an Iowa residence. Preference shall be given to Iowa participants residents.

**33.20(1)** *Fund distribution.* The total available funds will be distributed as follows:

<u>a.</u> The first \$50,000 will be awarded to public/private pre-K through grade 12 education disseminated as small grant awards not to exceed \$10,000 per request and no less than \$1,000 per request.

<u>b.</u> The next \$50,000 will be awarded to dissemination grants, if a dissemination project is provided by the department for the year.

<u>c.</u> <u>The remaining \$250,000 will be awarded for large grant awards not to exceed \$80,000 per request. Large grant awards require a minimum of 33 percent matching funds either as an inkind or a cash match.</u>

<u>*d.*</u> If all funds are not allocated through paragraphs 33.20(1) "*a*" and "*b*," the remaining funds will be allocated to qualifying projects in paragraph 33.20(1) "*c.*"

33.20(2) Expenditure guidelines.

<u>a.</u> Eligible program types. Applicants can apply for funding that supports hands-on interactive types of educational experiences, such as workshops, trainings, field trips, or classroom activities, or passive education experiences, such as interpretive or wayside signs, brochures or video programming, or education center exhibits.

<u>b.</u> Personnel expenses. Requests for personnel expenditures shall not exceed 40 percent of the total grant request and can only be used for staff directly engaged with the educational offering. Administrative support personnel are not eligible grant fund expenses. An awardee will provide documentation on actual hours worked in order to receive the 40 percent reimbursement costs for personnel. This does not include educator stipends or funding provided to individuals in order to attend a workshop, conference or training, all of which are allowable expenses under this grant program.

<u>c.</u> <u>Travel expenses. Reimbursement is for in-state travel only; mileage, lodging, and food expenses will be reimbursed at the current state rate as found on the department of administrative services website.</u>

<u>d.</u> Noneligible expenses. Grant funds cannot be used for technology or infrastructure development or construction whose singular function is not primarily and consistently dedicated to the program or exhibit for which grant funds are requested. Additionally, grant funds cannot be used for food and beverage costs or reimbursements.

ITEM 4. Rescind rule 571—33.21(455A) and adopt the following new rule in lieu thereof:

#### 571—33.21(455A) Competitive grant project planning and review committee.

**33.21(1)** *Review committee.* 

*a*. The director shall appoint a five-person review and selection committee to evaluate project applications. This committee shall include one representative of the department appointed by the director, one representative of the department of education science consultant or designee, one representative of the Iowa conservation education council, one representative of the Iowa

association of naturalists, and one representative of the Iowa association of county conservation boards. Additionally, there shall be at least one alternate identified and designated by the director from each represented organization. Terms of appointment to the committee shall be on a threeyear staggered term basis.

*b*. An individual who is a member, volunteer, or employee of an entity that has submitted a project shall not serve on the scoring committee during that award cycle. Instead, one of the alternates shall review and score in the individual's place.

#### **33.21(2)** *Competitive grant project selection criteria.*

*a*. Under the competitive grant program, a project planning and review committee shall establish criteria and scoring systems to be utilized in project evaluation. The criteria and scoring systems shall be submitted to the natural resource commission for approval.

*b*. The department shall publish on its website the date and time for submitting a funding proposal and the criteria and scoring system, providing at least 90 days' notice. Applications must be submitted to the department as described on the website.

*c*. Upon recommendation of the planning and review committee, the natural resource commission shall award the grants.

#### **33.21(3)** *Dissemination plan.*

*a*. After completion of the project awarded through the large grants, and prior to final request for reimbursement, the awardee shall complete a dissemination plan as provided on the department's website. Projects funded with conservation education program funds are intended to be replicable by other educators or conservation programs in Iowa.

*b*. Annually, the review and selection committee will review dissemination plans; select successful projects per criteria developed and approved by the natural resource commission; and

offer additional award opportunities, not to exceed \$10,000 per awardee, of up to \$50,000 of conservation education program funds for other educators or conservation education programs to implement.

**33.21(4)** Nonapplication of copyright. Program materials developed from REAP funds for conservation education materials shall bear the REAP logo. However, materials developed under this grant shall not be copyrighted by the grantee unless the department gives permission. A digital copy of all program materials developed shall be supplied to the department as part of the dissemination plan.

**Contract Purpose:** DU is dedicated to the increase and production of waterfowl and other migratory bird populations in Canada via restoration and preservation of wetland and grassland habitats. Conserving waterflow production habitats in Saskatchewan, Canada is critical to reaching and maintaining continental population goals as set forth in the North American Waterflow Management Plan. Iowa's State Duck Stamp was established to conserve continental waterfowl populations through habitat conservation projects in Iowa, with authority to provide up to fifteen (15) percent of the revenues to support habitat projects in Canada. This agreement is in recognition that the provinces of Saskatchewan and Manitoba represent the largest geographic portion of North America's Prairie Pothole Region, and that they provide critical nesting habitat for the same waterfowl populations that nest and migrate through the State of Iowa. Since the State Duck Stamp was established in 1972, Iowa has contributed more than \$1 million to conservation of waterfowl production habitat in Canada via annual cooperative agreements with DU. Du has submitted a funding proposal, 2025 Proposal to Conserve Critical Waterfowl Habitat in the Prairie Pothole Region of Saskatchewan.

The DNR's purpose in entering into this Cooperative Agreement is to support waterfowl habitat projects in the Prairie Pothole Region of Canada. DNR is dedicated toward the conservation of continental populations of waterfowl and other migratory birds, especially those that nest in the Prairie Pothole Region and migrate through the Mississippi Flyway and State of Iowa. DU's purpose in entering into this Cooperative Agreement is to increase and maintain abundant continental waterfowl populations through restoration and protection of wetland and other critical waterfowl production habitats in the Prairie Pothole Region.

# 15.1 Nishnabotna Wildlife Unit, Flood Damage Repairs Phase 6 – Fremont County

The Department requests Commission approval of the following construction project:

### **Project Summary:**

Missouri River flooding in 2019 caused infrastructure damage on multiple Wildlife Management Areas in the Nishnabotna Wildlife Unit. The DNR worked to receive FEMA public assistance funds for the repairs. FEMA obligated the

initial repair project in 2021. However, due to the remote locations of the damages, Engineering and field staff determined that it would be difficult to source enough commercial fill to complete the repairs. Therefore, we asked FEMA for approval to borrow fill from adjacent areas. This triggered an archaeological review and a new version of the project, which was obligated in 2023. This project has a significant number of damaged sites that need to be designed, permitted and bid out; therefore, Engineering has been designing the repairs in phases to get the work completed.

This project involves repairing blowouts and sloughing at Larson, Whitehead, Jensen, and Rose levees.

# **Project Summary:**

Missouri River flooding in 2019 caused infrastructure damage on multiple Wildlife Management Areas in the Nishnabotna Wildlife Unit. The DNR worked to receive FEMA public assistance funds for the repairs. FEMA obligated the

initial repair project in 2021. However, due to the remote locations of the damages, Engineering and field staff determined that it would be difficult to source enough commercial fill to complete the repairs. Therefore, we asked FEMA for approval to borrow fill from adjacent areas. This triggered an archaeological review and a new version of the project, which was obligated in 2023. This project has a significant number of damaged sites that need to be designed, permitted and bid out; therefore, Engineering has been designing the repairs in phases to get the work completed.

This project involves repairing washouts to an 800foot section of the Thompson Levee by building a new levee approximately 50 feet to the east.

# **15.3** Viking Lake & Lake of Three Fires State Parks, Pavement Preservation – Montgomery and Taylor Counties The Department requests Commission approval of the following construction project:

**Project Summary:** Viking Lake State Park and Lake of Three Fires State Park are in SW Iowa. Viking Lake is a 1000-acre park with a 136-acre lake in Montgomery County. Lake of Three Fires is a 1155-acre park with an 85-acre lake in Taylor County. Both parks are popular destinations for campers, anglers, hikers, bird watchers and nature enthusiasts. Both parks offer modern campgrounds, showers, restrooms, day use shelters, picnic areas, swimming areas, playgrounds, boating, and hiking trails. ### **Original Project Summary:**

This project has a significant number of damaged sites that need to be designed, permitted and bid out and Engineering has been designing the repairs in phases to get the work completed. This project involves repairing sloughing and washouts along 11,000 feet of dikes in various locations throughout the wildlife unit.

# **Amendment Purpose:**

During the pre-construction walk-through on April 28, 2025 damage to the existing paved road from previous construction in a different location was observed. There was surface damage in the middle of the road and significant cracking on the edge. To limit potential additional damage to the road, Salter Wetlands Associates recommended a long-reach excavator and heavy-duty matting. These changes will allow for the weight of the machine to remain in the center of the roadway and minimize surface damage.

This will require the road to be closed and a machine with a longer boom to reach the toe of the dike with a smaller capacity bucket. The smaller bucket and care to protect the pavement result in a slower production rate, leading to the increased cost for the contractor. DNR staff agrees that we should add measures to this project to protect the road from damages that will far exceed the value of this proposed change order.

#### \*18. Contract with the Story County Conservation Board (Hickory Grove Park)

**Background:** Hickory Grove Lake is a 100-acre constructed lake in Story County with a lake to watershed ratio of 40:1. According to the 2024 Lake Visitation Survey, the lake had around 40,000 visits and serves as a regionally important lake. The Story County

to the 2024 Lake Visitation Survey, the lake had around 40,000 visits and serves as a regionally important lake. The Story County Conservation Board (SCCB) reports that the park is popular camping and fishing destination within the county, and sees many visitors from within a 60-mile radius. Popular activities include fishing, camping, relaxing, and wildlife watching. While the fishery remained relatively healthy, carp limited the establishment of aquatic vegetation. Stormwater run-off led to gully erosion in watershed tributaries, debris (e.g. corn stalks) in the lake, and nitrogen spikes in samples collected from the watershed. Additionally, the beach at the lake has been listed as impaired due to high concentrations of indicator bacteria.

A technical advisory team was formed in 2008 to plan and implement water quality improvement efforts. This team of partners implemented watershed improvement practices on private and public land to reduce sediment and nutrient delivery to the lake. In-lake practices, such as shoreline stabilization, targeted sediment removal, and a fishery renovation were targeted at reducing internal nutrient loading. These practices included a livestock exclusion project, cost-share program to upgrade watershed septic systems, and goose population control at the beach. Lastly, dam infrastructure, shoreline access, and outdoor recreational opportunities were enhanced as part of this comprehensive restoration project. The total lake restoration project cost was approximately \$4 Million, which was shared between the Iowa DNR's Lake Restoration Program (70%) and the County (30%). Project partners held a grand re-opening celebration in 2021 to showcase the project to the community.

Despite the aforementioned restoration efforts, the lake is still impaired due to elevated levels of indicator bacteria at the beach. As with many parks around the state, the beach at Hickory Grove Lake is impacted by drainage around the beach area, which contributes to elevated bacteria levels. Research completed over the past 10 years at DNR shows indicates that where sand remains wet following rain events, especially in places where there is a lot of runoff, the lake is more likely to show elevated levels of bacteria at the beach. Thus, channeling drainage away from the beach, when coupled with other stormwater management practices, should yield fewer violations to the state's beach bacteria water quality criteria.

**Contract Purpose:** The purpose of this agreement is to work with SCCB to hire a consultant to provide engineering services for proposed beach area improvements at Hickory Grove Lake to minimize runoff at the beach and reduce the frequency of beach bacteria violations. The consultant will provide design, engineering and permitting for stormwater management infrastructure, beach and hillside grading, and native plantings. These improvements are expected to reduce indicator bacteria at the beach and potentially remove the lake from Iowa's Section 303(d) Impaired Waters List.

Anticipated Future Work: The LRP will pursue construction of stormwater management infrastructure, beach and hillside grading, and native plantings to reduce indicator bacteria at the beach and potentially eliminate the impairment. SCCB is committed to improving the usability of the beach area. Plans to enhance access and the amenities near the beach will complement the stormwater improvements. The County has proposed three shelters and a fire pit area, stone terrace retaining walls, reinforced concrete steps, sidewalks, a kayak launch, and watercraft rental lockers. Total anticipated cost for construction these improvements practices is around \$1.1 million, which will be cost-shared between the LRP and SCCB.

# **Contract Purpose:**

The purpose of the contract is to conduct a study to assess the current status of the rusty-patched bumble bee (*Bombus affinis*; RPBB) on public lands in Iowa. The RPBB was listed by the U.S. Fish and Wildlife Service (USFWS) as endangered under the Endangered Species Act effective Tuesday, March 21, 2017. Recovery of the RPBB is reliant upon conservation partners implementing actions intending to address populations declines and increase knowledge of the species as described in the Recovery Plan for Rusty Patched Bumblebee (Plan) and the Recovery Implementation Strategy for the Rusty Patched Bumble Bee (*Bombus Affinis*) Version 1.0 (RIS). There is a need for the Iowa Department of Natural Resources (DNR) to collect RPBB information in order to effectively plan for and implement actions important for species recovery in Iowa. In this effort, the DNR is proposing to conduct surveys and monitoring consistent with recovery criteria defined in the Plan and CU2 objectives and priorities outlined in the RIS. The DNR intends to use this information for conservation and management planning. Contract tasks include: 1) RPBB surveys and basic habitat assessments at a minimum of 20 sites in conservation priority grids and 2) Detailed habitat assessments at a minimum of five sites within the study area with a positive identification of RPBB.

# \*21. Publicly Owned Lakes Watershed Eligibility Program– FY25

## Purpose:

This process establishes a priority list of watersheds above significant public lakes where private landowners are eligible to receive cost-share moneys to establish soil and water conservation practices. Funds for these practices are set aside in appropriations to the Department of Agriculture and Land Stewardship (IDALS), Division of Soil and Water Conservation.

In order to be eligible to receive IDALS's Publicly Owned Lakes Watershed (POLW) Program funds, an applicant must be a soil and water conservation district and apply for POLW priority designation to IDALS - Division of Soil and Water Conservation. Applications are submitted annually, as specified by the Division. The Division then forwards applications to the Department for determination of program eligibility.

The Department reviews applications based on compliance with application requirements. For example, the application requests a map of the watershed identifying the sources and estimated sediment delivery to the lake; and, description, location, estimated costs and estimated reduction of sediment delivery for each planned practice that will be implemented pending program funding. The purpose is to target locations within the watersheds that contribute significant sediment to the lake for installation of permanent or management soil conservation practices.

**Summary of Selection Process:** As outlined in Iowa Administrative Code 571, Chapter 31, Publicly Owned Lakes Watershed Program, the DNR is responsible for the application review and recommendation process. The DNR is to then submit the recommended list of watersheds above significant public lakes eligible under the program for the upcoming year to the Natural Resource Commission for approval. The Review and Selection Committee evaluated applications based on the criteria above.

This cooperative agreement describes the roles and responsibilities of all parties involved in the management of the designated riding area named Nicholson Ford OHV Park in Marshalltown, Iowa. Nicholson Ford is located on property owned by the City of Marshalltown. The riding area was designated by the Commission in 2005. The City of Marshalltown leases the property to a local non-profit riding club, Iowa River OHV Club, who provides maintenance at the riding area. Currently the bureau manages approximately 1,800 capital assets including buildings, roads, boat ramps, parking lots, playgrounds, trails, water and wastewater treatment and distribution systems, utilities, and land improvements. Inventory and condition data for these assets is currently housed in multiple systems and spreadsheets within the agency. To ensure fiscal prudence, manage risk, and maximize return on investment this data must be housed and managed in one system that is user-friendly and accessible to all staff from park technicians to bureau leadership. A central asset management system will allow the Department to better assess the condition of assets, schedule capital maintenance projects, and budget for routine maintenance into the future. The system will also allow the Department to more efficiently and accurately report on the condition of its assets.

This contract includes an annual subscription to Opengov Asset Management which will house inventory of all capital assets managed by the State Parks, Forests and Preserves Bureau as well as condition assessment records, maintenance records, and preventative maintenance schedules for those assets. The system will allow park managers, supervisors, and program administration staff to monitor maintenance needs and condition ratings of facilities in real time.

Initial implementation services by the vendor include configuration of existing GIS data, creation of preventative maintenance templates for various asset types, creation of condition assessment checklists, staff training, and customer support following launch.

Asset management is a core function of the State Parks System and the need for an improved asset management system has been identified as a priority in the Department's FY2025-2026 Strategic Plan. Opengov Asset Management is currently used by Texas State Parks, South Dakota State Parks, and Virginia State Parks.
