

6. Contract with Friends of Beeds Lake State Park, Inc.

Commission approval is requested for a contract with Friends of Beeds Lake State Park, Inc., of Hampton, IA.

Contract Terms

Amount: Not to exceed \$187,507

Dates: August 15, 2025 to December 31, 2026

Funding Source(s): 40% Parks Infrastructure, 60% Friends of Beeds Lake State Park, Inc.

Contract Purpose: Beeds Lake State Park and the Friends of Beeds Lake State Park, Inc. are partnering to purchase and install new playground equipment to replace an existing playground. The existing playground equipment reached the end of its usable life and did not provide accessible play opportunities to the public.

The new playground will feature modern, inclusive equipment that meets current accessibility standards, along with an adjacent sidewalk and parking area to improve access. Playground facilities at Beeds Lake State Park are a valued amenity for families and children who visit the park.

Friends of Beeds Lake State Park, Inc., a nonprofit organization established to promote and enhance Beeds Lake State Park and the Iowa State Parks system, is playing a key role in this effort. The equipment identified in this contract will be procured and installed using the professional services of a contracted vendor under a Department of Administrative Services Master Agreement.

*7. Contract with Brown's Tree Service LLC dba BTS Sanitation

Commission approval is requested for a service contract amendment with Brown's Tree Service LLC dba BTS Sanitation of Fairfield, IA.

Contract Terms

Amount: \$35,295.00

Dates: December 1, 2025 to November 30, 2027

Funding Source(s): General Fund

Contract Purpose: This contract provides services for year-round collection, hauling and disposal of garbage from Lake Darling State Park. Brown's Tree Service LLC, doing business as BTS Sanitation based in Fairfield, lowa, is the current service provider. The company has consistently responded to service requests and fulfilled them in a timely manner.

Lake Darling State Park has five designated areas with dumpsters, one of which is a campground that generates a high volume of trash. During peak season, trash removal service is essential for general park users, renters of our day-use facilities, and campers. This service is vital for continuing to provide the quality and standards that park users have come to expect from Iowa State Parks while also allowing park staff to maintain their facilities and grounds.

Contract tasks include:

- Peak Season Collection (April October): Weekly service to empty 9 dumpsters at all 5 locations (1 time per week).
- Extra Rec Use Collection (April September): Weekly service to empty 9 dumpsters at all 5 locations (1 time per week).
- Off Season Collection (November March): Weekly service to empty 3 dumpsters at 3 locations (1 time per week).
- On-call Collection: As requested.

Selection Process Summary: The Department issued a Request for Quote (RFQ) in 2023 by posting on the Department of Administrative Services Bid Opportunities website.

8. Subrecipient Grant Agreement with National Audubon Society

Commission approval is requested for a Subrecipient Agreement with National Audubon Society, of Roseville, Minnesota.

Agreement Terms

Amount: Not to exceed \$240,874

Dates: August 15, 2025 to September 30, 2028

Funding Source(s): America the Beautiful Challenge grant

Agreement Purpose: Prairies and savannas in the Midwest continue to be lost due to agricultural and urban development and invasive species resulting in the degradation of ecosystem services, including preventing soil erosion, improving soil development, filtering and recharging groundwater, increasing streamflow and sequestering carbon. Improved management of these systems increases their drought resilience, soil carbon storage, nutrient reduction and water retention, which supports human communities across lowa and the Midwest. The Tallgrass Prairie Ecosystem hosts more than 70 Regional Species of Greatest Conservation Need. Since these species inhabit fragmented habitats across multiple states, it is crucial to conserve them through landscape-level, interjurisdictional and public-private efforts to conserve grasslands. The Midwest portion of the Tallgrass Ecosystem serves as a major migration corridor and summer breeding range for monarch butterflies, other insects, birds and bats, and increasing connectivity to enhance migration habitat within this critical corridor can only be accomplished through landscape-level coordinated efforts. Conservation efforts will be targeted in focal areas with concentrations of at-risk species and implement management practices, including invasive plant control, prescribed fire, planned grazing and prairie restoration that benefit these species. Also, by working strategically to restore grasslands and remove invasive trees and shrubs from existing prairies and oak savannas/woodlands, this project will re-establish connectivity and corridors to benefit these species. Additionally, enhancing and restoring these plant communities will enhance a range of ecosystem services, benefiting local citizens.

23.1 Triboji Dock Management Area Shoreline Repair & Stabilization – Dickinson County

The Department requests Commission approval of the following construction project:

Project Summary: In the summer of 2024 the lowa Great Lakes Region received heavy precipitation that raised the water level of the lakes causing erosion and bank collapses along the shorelines. The Triboji Dock Management Area (DMA), located just south of the Triboji boat ramp, was one of the DNR owned public areas that this damage occurred. About 400' of West Okoboji Lake Shoreline was damaged by the high water and then subsequent wave action. This project is being done separate of the upcoming larger Great Lakes Shoreline Repair project due to this being publicly

owned and accessible from land. The larger future project will be mostly completed with barge access and that is the reason the projects are being contracted separately.

This project will repair the bank erosion by refilling the eroded areas with soil and then installing rock revetment to prevent future erosion. An additional 200' of shoreline beyond the damaged area will also receive additional armoring so that the entire DMA area is stabilized for the next high water event.

In addition to the shoreline repair, 10 Ash trees will be removed from the DMA as they are showing signs of stress and dying from Ash borer infestation and/or need to be remove to complete the repairs.



23.2 Steamboat Rock Dam Mitigation - Hardin County

The Department requests Commission approval of the following construction project:

Project Summary: The Steamboat Rock Dam is located across the lowa River, on the west side of the town of Steamboat Rock. The dam was originally constructed of wood planks and rock in 1855 to provide power to a sawmill. This dam was replaced with a concrete structure in the 1930's by the Works Progress Administration and the Civilian Conservation Corps, then rebuilt again to its current design in 1941. The existing structure presents a hazard to boaters and a barrier to fish passage.

This project will remove the existing concrete dam in four stages, in order to control downstream sediment release. A series of rock and boulder structures will be constructed upstream of the dam and the river banks will be reshaped and vegetated to stabilize the river channel. A gravel parking lot and a new canoe/kayak access will be constructed on the bank adjacent to the county campground. Another canoe/kayak access will be constructed adjacent to the county bridge.



23.3 Pleasant Creek State Recreation Area, Campground Improvements - Linn County

23.4 Lake Keomah State Park, Spillway Floor Concrete – Mahaska County

The Department requests Commission approval of the following construction project:

Project Summary: The Lake Keomah dam and spillway were originally constructed in 1935 to create an 82-acre lake. The original spillway was replaced in 1966. This spillway had patch work done on the floor and new wall sections poured in 1992. The 1992 walls had surface repairs done earlier this year. The floor has also deteriorated and needs repairs.

After a sounding evaluation of the floor, it was discovered that over 50% of the surface area has become delaminated. This project will construct a new 6" concrete overlay over the existing spillway. 



26. Contract with Shive-Hattery, Inc. (Springbrook Geotech and Design)

Commission approval is requested for a contract with Shive-Hattery, Inc. of West Des Moines, IA.

Contract Terms:

Amount: Not to exceed \$51,500.00

Funding Source(s): Parks and Institutional Roads Fund

Contract Background: The DNR Seeks to Purchase: Engineering services from a qualified engineering consulting firm for a geotechnical investigation, survey, and design to repair a roadway failure that is impacting the roadway east of the Lake at the Springbrook State Park in Guthrie County.

Contract Purpose: For Phase 1 of this contract, Shive-Hattery, Inc. will provide a certified Geotechnical Investigative Report (GIR) of the site, which will include an assessment of slope stability, soil testing results, summary of standard test methods used, possible cause of roadway failure, risk of future slides at the site; and, short (~5 years) and long (>15 years) term recommendations.

At the sole discretion of the Department, the Department will make a determination on moving forward with additional services related to implementation of Phase 2, developing roadway slope stabilization construction plans and specifications that efficiently stabilize the damage. Hourly rates provided by Shive-Hattery, Inc. will be used as a basis for contracting any additional design and oversight work to be completed as a part of Phase 2.

As part of Phase 2, Shive-Hattery, Inc. will prepare final design in accordance with lowa Department of Transportation specifications, including final plans and cost estimates. Shive-Hattery, Inc. will be responsible for coordinating the process with Department staff, obtain all permits, perform needed survey's, perform any needed additional geotechnical services, assist the Department with bid letting, conduct an onsite preconstruction meeting, perform needed materials testing during construction, and will be retained during construction for onsite inspection assistance at critical construction milestones. The Department will facilitate the construction bidding/contracting process and all the day-to-day construction inspection duties.
