***6. Chapter 30 - Waters Cost-Share and Grant Programs, Water Recreation Access Cost-Share (WRAC) Grants (FY 2026)**

The Commission is requested to approve funding for the recommended Water Recreation Access Cost-Share (WRAC) Grant applications pursuant to Iowa Administrative Code Chapters 571-30.

Grant Purpose: The Water Recreation Access Grants are awarded annually to assist governmental entities in providing or improving water access for recreation purposes. State cost-share funding is provided at 75% with the local 25% contribution coming from in-kind or monetary match if the project is not under a management agreement with the State of Iowa. Grantees can receive cost-share funding at 100% if they are managing the property under an agreement on behalf of the State of Iowa.

Funding Source: Marine Fuel Tax

Grant Funding Available: \$400,000

Summary of Selection Process: Grant applications are scored through a two-part process. Initially, grants are reviewed by district staff and are given a general overall rank. The grants are then submitted to the central scoring committee who review each grant and make final selections based on eligibility, justification, work plan and district ranking. Grant applications were reviewed and scored by a committee who met on October 28, 2025, according to rules provided for in Iowa Administrative Code chapter 571-30.

Selection Committee Members: The review committee consists of 7 members:

Contract with IOWA STATE UNIVERSITY

Recommendation:

Commission approval is requested for a service contract, which is a Subrecipient Agreement, with Iowa State University, Department of Natural Resource Ecology and Management. This Subrecipient Agreement designation has occurred due to the nature of ISU's work on the project, which is being conducted as a part of a Competitive State Wildlife Grant application.

Contract Terms:

Amount: Not to exceed \$165,000

Dates: January 1, 2026 to June 30, 2028.

Funding Source(s): Federal USFWS State Wildlife Grant Program Competitive Funds.

Statutory Authority: This Subrecipient Agreement is an intergovernmental contract authorized by 11 Iowa Administrative Code Section 118.4. Also, Iowa Code section 455B.103(3) allows DNR to enter into contracts, with approval of the commission, with public agencies of this state to provide laboratory, scientific field measurement, and environmental quality evaluation services.

Contract Purpose: The parties propose to enter into this Subrecipient Agreement to retain ISU to: work towards a larger Competitive State Wildlife Grant application titled "Priority Monitoring, Research and Habitat Management Activities to Conserve the Eastern Massasauga Rattlesnake, Timber Rattlesnake, and Plain-bellied Watersnake" with Illinois DNR and Wisconsin DNR. The overall grant will allow for habitat work to help the Eastern Massasauga Rattlesnake, and monitor their numbers along with examining genetic diversity compared to snake fungal disease prevalence in all three snake species.

This Subrecipient Agreement will allow ISU to collect genetic and skin swabs from all three species of the snakes, ISU will process those samples to determine genetic health of the species in Iowa and whether there are any correlations between genetic health (i.e. inbreeding) and disease prevalence. In addition, there is some confusion as to the true species of the Plain-bellied Watersnake (previously Copper-bellied and also Yellow-bellied) in Iowa and DNR hopes to be able to determine which species occurs here and how it is related to the same or sister species of the same (Plain-bellied) complex. The goal is to examine the genetic health of all three of the populations and assess them for impacts from the fungus, looking to see if there is a relationship between in-breeding and disease prevalence.

The total cost for this agreement is \$220,000. The DNR will provide funding (up to \$165,000) for ISU to complete the genetic and disease testing. ISU will provide up to \$55,000 in matching funds for the project. This three-year contract will support a graduate student and an undergraduate research assistant.

ISU tasks include:

- Working with TNC to collect blood, skin, and fungal samples from Eastern Massasauaga Rattlesnakes
- Collecting blood, skin, and fungal samples from Plain-bellied Watersnakes and Timber Rattlesnakes
- Processing those samples
- Analyzing the data provided from the samples to determine health of the populations
- Re-examining the species status of Iowa's Plain-bellied Watersnakes

Contractor Selection Process:

- Intergovernmental contracting is authorized by 11 IAC 118.4, and Iowa Code section 455B.103(3) allows DNR to contract with ISY for this purpose. Iowa State University was chosen for this project because they were a partner on the grant application and have the experience and knowledge to do the work.

Contract with IOWA CHAPTER OF THE NATURE CONSERVANCY

Recommendation:

Commission approval is requested for a service contract, which is a Subrecipient Agreement, with The Nature Conservancy. This Subrecipient Agreement designation has occurred due to the nature of TNC's work on the project, which is being conducted as a part of a Competitive State Wildlife Grant application.

Contract Terms:

Amount: Not to exceed \$45,000

Dates: January 1, 2026 to December 30, 2028.

Funding Source(s): Federal USFWS State Wildlife Grant Program Competitive Funds.

Statutory Authority: This subrecipient agreement is authorized by Iowa Code 455B.103(3) and 481B.4.

Contract Purpose: The parties propose to enter into this Sub-recipient Agreement to retain TNC to: work towards a larger Competitive State Wildlife Grant application titled "Priority Monitoring, Research and Habitat Management Activities to Conserve the Eastern Massasauga Rattlesnake, Timber Rattlesnake, and Plain-bellied Watersnake" with Illinois DNR and Wisconsin DNR. The overall grant will allow for habitat work to help the Eastern Massasauga Rattlesnake, and monitor their numbers along with examining genetic diversity compared to snake fungal disease prevalence in all three snake species.

This sub-recipient agreement will allow The Nature Conservancy (a partner on the grant application) to manage habitat on their land specifically for the Eastern Massasauga Rattlesnake as well as monitoring that population and collecting blood samples and snake fungal disease swabs from these federally protected snakes. TNC already holds the required Federal permits to be able to collect the samples from this species. The goal is to examine the genetic health of the population and assess it for impacts from the fungus, looking to see if there is a relationship between in-breeding and disease prevalence.

Vegetational succession, habitat fragmentation, and habitat loss and modification are primary threats for EMR. The three State Agencies partnering on this grant contain all known extant populations in the Eastern Massasauga's Western Conservation Unit. The largest population in each State is being targeted for actions under this grant.

Contractor Selection Process:

- The Nature Conservancy was chosen for this project because they have substantial experience with the federally protected Eastern Massasauga Rattlesnake. They were a partner on the grant application and will be providing \$15,000 (25% of their total project costs) towards the matching funds needed for the grant. Iowa Code 481B.2 and 481B.4 provide the statutory authority for the DNR to spend money on habitat work and research for an endangered or threatened species. Iowa Code 455B.103(3) allows for scientific field measurement and Iowa Code 481B.4 allows for the habitat management and other tasks due to the State of Iowa Endangered status (Federally Threatened) of the Eastern Massasauga.




Contract Background: High nutrient loading in Iowa Lakes, particularly phosphorus, has accelerated eutrophication of lakes and consequently degraded their water quality, impacted their ecological health and diminished recreational opportunities. Frequent and pervasive algal blooms, low water transparency, noxious odors, depletion of oxygen, and fish kills have been observed and are even common in Iowa lake systems during the open water season.

The Lake Restoration Program (LRP) has been working to develop new tools for managing phosphorus in lakes over the past five years, particularly those that are effective at treating internal phosphorus recycling. The LRP first worked with researchers from Iowa State University and the University of Wisconsin – Madison (Contracts 18CRDLWBMBALM-0013 and 22CRDLWBMBALM-0002) to better understand mechanisms for internal loading in Iowa Lakes (2020-2023 study) and develop strategies for managing different pathways of internal loading.



In 2023, the LRP hired Barr Engineering to investigate the utility of alum as a tool in nine Iowa Lakes, including Lake of Three Fires, Green Valley Lake, and Prairie Rose Lake. As a part of this study, sediment cores were collected and analyzed for each lake to estimate internal loading rates and develop a dosing strategy and cost benefit analysis for treating each lake. Green Valley Lake and Prairie Rose Lake, both of which were excellent candidates for an alum application, were treated in the spring and fall of 2025. Lake of Three Fires was also identified as a good candidate, and additional water quality monitoring was completed in 2025 to ensure that it would be a good place for an alum application program.

Green Valley Lake (top): Located in Union County, Green Valley Lake is a 390-acre lake that has a long history of frequent algae blooms and high phosphorus concentrations. Following the spring 2025 application, water quality improved dramatically, and phosphorus concentrations in the lake remained lower than observed in previous years throughout the summer, in spite of high rainfall. Only green areas of the lake in the photo above (in-lake sediment basins) will be treated as a part of this contract)




Prairie Rose Lake: Prairie Rose Lake is a 173-acre constructed lake with a watershed to lake area ratio of 24:1. Low fish populations, siltation, and poor water quality plagued the lake in recent years, thus watershed and lake improvements were planned to bring this popular recreation destination back to life. Many watershed and in-lake practices were completed between 2010 and 2015, however; phosphorus concentrations in the bottom waters of the lake remained high, which led to substantial internal loading. While the lake is reputed as being one of the best fishing lakes in the state and has become an extremely popular recreation destination, reducing the

internal load is key to maintain long term water quality benefits. The alum treatment in the spring of 2025 led to 20ft water clarity shortly after the treatment and numerous anglers reported being able to site fish around the shoreline. Phosphorus concentrations were lower than previous years as well. Water quality has remained good throughout the summer, with the lake experiencing only one algae bloom following a heavy rainfall event. Only the purple area (in-lake sediment basin) will be treated in the spring of 2026 as a part of this contract.

Lake of Three Fires: A 97-acre lake, located in Taylor County, Lake of Three Fires is a popular local destination and was one of the earliest restoration projects in Iowa. While the lake supports a variety of popular recreation opportunities, water quality is diminished by internal loading. It's small size and small watershed, coupled with its large internal load, make it a good candidate for alum. The lake will be treated, both in the spring and fall of 2026 with alum, similar to the approach previously utilized at Green Valley Lake and Prairie Rose Lake.

Contract Purpose: The purpose of this project is to hire a qualified firm to complete alum applications at Green Valley Lake (Union County) in-lake sediment basins, and Prairie Rose Lake (Shelby County) in-lake sediment basin, and at Lake of Three Fires (Taylor County). Applications will be completed both in the spring of 2025 at all three locations and the fall of 2025 (Lake of Three Fires only) to inactivate sediment phosphorus and improve water quality.



Selection Process Summary: The department solicited proposals from targeted small businesses and published a Request for bids (RFB) on the Department of Administrative Services website.

Proposal Due Date: October 1, 2025

Scoring Criteria: Proposals were scored based on meeting technical specifications for the project at cost.

11.1 Pine Lake State Park, Parking Improvements – Hardin County

The Department requests Commission approval of the following construction project:

Project Summary: Pine Lake State Park is located northeast of Eldora, and borders the Iowa River. The park contains wooded trails, deep ravines, and scenic views of Upper and Lower Pine Lake. Historic structures built by the Civilian Conservation Corps (CCC) and Works Progress Administration (WPA) can be found throughout the park, including the Pine Lodge, beach house and stone cabins, which have been carefully restored. Boat ramps on the Iowa River and both lakes provide opportunities for recreation.



Commission approval is requested for a contract with Endeavor Civil Engineering (Endeavor) of Delhi, IA.

Contract Terms:

Amount: Not to exceed \$154,620.00

Dates: December 1, 2025 to December 1, 2027

Funding Source(s): 75% FEMA; 25% Executive Council

Contract Background: The DNR Seeks to procure engineering services from Endeavor for the design of flood damage repair work at Green Island (Jackson Co.) and Princeton (Scott Co.) Wildlife Management Areas (WMA's). The project is needed to repair damage sustained under FEMA declared disasters DR4732 (2023) and DR4796 (2024). Funds have been obligated by FEMA for these repairs.

Contract Purpose: Endeavor will prepare final designs, including drawings, specifications, and cost estimates. Original Project Summary:

Red Haw State Park, a 649-acre park in south-central Iowa near Chariton, first opened in 1939. Amenities include a 70-acre lake, a modern campground with electric sites, a hiking trail, a beach, and a CCC stone picnic shelter.

On March 5, 2022, a tornado significantly damaged the campground. As part of the rebuild, the Iowa DNR reconfigured 34 campground sites to meet current design standards. This included reconstructing a road along the shower building that was damaged during cleanup, paving three ADA-accessible sites, and installing 34 new 50-amp electric outposts.

Amendment Purpose:

During a recent inspection, the electrical inspector required an upgrade to an 800-amp electrical panel with a main shutoff. The previous panel lacked a main shutoff, and one could not be retrofitted. This upgrade will also include a CT cabinet, which is required by Alliant Energy. An electrical CT cabinet is a metal enclosure designed to house current transformers, safely measure large electrical currents, protect users from electric shocks, and safeguard transformers from harsh environmental conditions.

Original Selection Process Summary: The DNR used a formal competitive bid process. Nagel Construction, LLC was awarded the contract as the low bidder. Any change order which increases the amount of the original contract by more than \$25,000 or 10 percent of the original contract, whichever is greater, requires commission approval.
